The Great Lakes-Gulf Presbytery met for its annual Spring Meeting on Thursday March 2 at 2:00 p.m. at the Reformed Presbyterian Church of Columbus, Indiana.

BUSINESS SESSION #1

Thursday 2:00 - 5:30 p.m.

1. CALL TO ORDER

The moderator, Mr. H.P. McCracken, called the meeting to order at 2:05 p.m. The presbytery sang Psalm 22D to the praise of God.

Mr. McCracken read Philippians 1:12-18, preached from the text on Paul's ministry report from prison to the Philippian church, highlighting the glorious victory of Christ's gospel over various daunting hindrances..

He then constituted the court in prayer.

2. ROLL CALL

The assistant clerk, Mr. Hemken, called the roll and confirmed that a quorum was present.

All attendance and voting records from this meeting are included in Appendix 1.

3. INTRODUCTION OF FIRST-TIME DELEGATES

Mr. Niess introduced Mr. Averette Woodson, ruling elder from Selma RPC.

Mr. Knodel introduced Timothy Vincze, ruling elder from SWORP.

4. CLERK'S REPORT

Mr. Kuehner presented the clerk's report.

Recommendation 1 was seconded and passed.¹

Recommendation 2 was seconded and passed.²

5. ASSISTANT CLERK'S REPORT

Mr. Hemken issued a call for papers and none were received.

It was moved, seconded, and passed to close the nominations, after which Mr. Kuehner and Mr. Hemken were elected by the court.

7. RULING/TEACHING ELDER MEMORIALS

The memorials for Rev. Roger Adams and Rev. Milton Harrington were deferred to a later time during this meeting.

8. AD INTERIM COMMISSION REPORT

Mr. Anderson presented the Ad Interim Commission Report. It was moved, seconded, and passed to refer Recommendation 19 back to the Ad Interim Commission to consult with the parliamentarians regarding a possible need to expunge certain statements made on page 9 of their minutes. Mr. Ketcham answered questions from Mr. McKenzie and then from the floor of presbytery.

It was moved, seconded, and passed to extend the time ten minutes in order to ask further questions of Mr. Ketcham.

Mr. Ketcham answered further questions from the floor and received further comments.

It was moved, seconded, and passed to extend the time another ten minutes to allow more comments from the floor, after which more comments were made.

It was moved, seconded, and passed to extend the time another ten minutes to hear additional comments from the floor, after which additional comments were made.

It was moved, seconded, and passed to extend the time in order to vote on the exam.

Mr. Hemken called the roll and announced that the exam, which requires a two thirds majority, was not sustained by a vote of 23 (Sustain), 20 (Not Sustain), and 4 (Abstain).

The following delegates registered their dissent from this action of the court: Mr. Pockras, Mr. Knodel, Mr. Keddie, Mr. Kuehner, and Mr. Anderson.

Prior to the next day's business session, in accordance with DCG 7.18 (D-39), a written statement outlining the reasons for this dissent was received by the clerk, bearing the names of Mr. Pockras, Mr. Keddie, and Mr. Knodel.

The statement is as follows:

THE UNDERSIGNED DISSENT FROM THE DECISION OF THE GREAT LAKES-GULF PRESBYTERY OF THE RPCNA TO NOT SUSTAIN SAMUEL KETCHAM'S "SYSTEMATIC THEOLOGY AND DISTINCTIVE PRINCIPLES" EXAMINATION FOR THE FOLLOWING REASONS:

- (1) The expressed opinions of many who voted not to sustain were opposed to positions once held by the RPCNA and still held by many officers and members.
- (2) The expressed opinions of many who voted not to sustain were opposed to positions held by other sections of the Reformed Presbyterian Church in other parts of the world, particularly in the United Kingdom and the Republic of Ireland.
- (3) The expressed opinions of many who voted not to sustain were opposed to granting dissent on these issues, which have been regularly allowed in the past.
- (4) The expressed opinions of many who voted not to sustain seem, to us, to undercut the very same procedures that were previously used to change the beliefs and practices within the RPCNA since 1945, including practical political dissent, much of what was understood on public social covenanting, close communion, and the use, sale, and manufacture of alcoholic beverages, among others.
