BUSINESS SESSION #1

Thursday 2:00 - 5:30 p.m. (Break @ 3:30a)

The Great Lakes-Gulf Presbytery met at the Orlando RP Church at 2:00pm on Thursday February 28, 2019 for its annual spring meeting.

1. CALL TO ORDER

The moderator called the court to order at 2:01 p.m. with the singing of Psalm 57B, after which he called upon God's name in prayer, read Ephesians 4:1-16 and Psalm 133, and preached on the theme of Christian unity, highlighting various causes of (and remedies for) disunity in the church.

 The court responded by singing Psalm 34B to the praise of God and Mr. Anderson constituted the court in prayer at 2:44 p.m.

2. ROLL CALL

Mr. Koons took attendance by calling the roll, after which he confirmed that a quorum was present.

3. INTRODUCTION OF FIRST-TIME DELEGATES

Mr. Olivetti introduced Mr. Zachary Blackwood and Mr. Nate Pfeiffer, both newly-elected ruling elders at Immanuel RPC in West Lafayette, Indiana.

4. CLERK'S REPORT

Mr. Kuehner presented the clerk's report.

6. ELECTION OF MODERATOR

It was moved, seconded, and passed to nominate Mr. Wade Mann to serve as moderator, after which it was moved, seconded, and passed to close nominations, and Mr. Mann was elected.

7. RULING ELDER MEMORIAL

Mr. Frank Smith submitted a written memorial for Elder Bob Shapiro, which the presbytery received by common consent.

8. AD INTERIM COMMISSION REPORT

Mr. Kuehner presented the Ad Interim Commission report.

 It was moved, seconded, and passed to approve the Ad Interim Commission report and to spread its minutes on the minutes of presbytery.

9. TREASURER'S REPORT

Mr. Bishop presented the treasurer's report, after which it was moved, seconded, and passed to receive the report.

10. INTER-CHURCH LIAISON REPORT

Mr. Knodel presented the Inter-Church Liaison report, after which it was moved, seconded, and passed to receive the report.

11. SHEPHERDING COMMITTEE REPORT

Mr. Frank Smith presented the Shepherding Committee report, after which it was moved, seconded, and passed to extend the time to finish the report.

- In response to a question from the clerk, clarification was offered regarding the process of seeking approval from the Ad Interim Commission when transferring members from the roll of presbytery.
- It was moved, seconded, and passed to approve the report.

12. MID-AFTERNOON BREAK

Mr. H.P. McCracken made several announcements on behalf of the host congregation, after which the court took its mid-afternoon break at 3:35 p.m.

Mr. Mann called the meeting to order at 8:32 a.m. with the reading Lamentations 3:23-24 and the singing of Psalm 67C, after which he appointed Mr. Pockras to serve as clerk *pro tem* and called upon God's name in prayer to constitute the court at 8:36 a.m.

90. ATLANTA COMMISSION REPORT

Mr. Anderson resumed the report of the Atlanta Commission, after which an updated version Recommendation 333 passed, thereby calling Rev. Frank J. Smith as the organizing pastor in the Atlanta mission church, upon the following terms: We, the Great Lakes-Gulf Presbytery, satisfied that your spiritual attainments, intellectual abilities and soundness in the faith and the Testimony of the Reformed Presbyterian Church are fitted to the capacities of the Atlanta Reformed Presbyterian Mission Church (ARPMC), do now call you, Frank Smith, to undertake the office of organizing pastor to take the spiritual oversight of the Atlanta RP Mission Church. Upon your accepting this call and performing the duties of your office as set forth by the Constitution, we promise you all due respect and support in the Lord. From the funds of the ARPMC you will be paid \$19,700, in the event of your accepting this call, and performing the duties of a pastor of ARPMC—a direct compensation of \$19,700, payable in 12 installments. This compensation is designated as housing allowance as set forth by Section 107 of the I.R. Code. The Presbytery will not be responsible for any of these funds. To provide for the pastor's continuing pastoral development and refreshment, the ARPMC will provide pulpit supply in order for the pastor to attend an annual professional conference. The pastor will be provided the Pension of \$4,300 annually. Presbytery and Synod accommodations will be reimbursed by ARPMC up to \$300 annually. Pastoral Ministry expenses will be reimbursed by ARPMC up to \$300 annually. Three weeks will be provided for vacation time each year. The pastor is expected to attend all Synod and Presbytery meetings. We promise to review annually with you the adequacy of this compensation prior to the adoption of the congregation's budget meeting to take into account the cost of living increase (e.g., C.P.I.). In witness thereof, we subscribe this call and financial agreement, the 2nd day of March in the year 2019 Anno Domini.
