SCHEDULE

Business Session (Noon - 5:00p) *Two 15-min breaks @moderator's discretion*

The Great Lakes-Gulf Presbytery met at noon on Friday September 11, 2020 by an edict of the moderator for "the consideration of the LeFebvre Writings Study Committee report and associated recommendations."¹

1. CALL TO ORDER / DEVOTIONS

The moderator, David Hanson, called the court to order at 12:00 p.m. with the singing of Psalm 119Q, then addressed the court from 2 Samuel 23:1-5, urging the delegates to humility and hope as they seek to conduct the business of the day with a gracious tone toward their brethren.

2. PRAYER OF CONSTITUTION

Kent Butterfield constituted the court in prayer at 12:15 p.m.

3. ROLL CALL / QUORUM (Asst. Clerk, Dale Koons)

The assistant clerk, Dale Koons, called the attendance roll and confirmed that a quorum was present.

4. MEETING RATIFICATION

In accordance with DCG 7.4 (D-31), it was moved, seconded, and passed to sustain the action of the moderator in calling the meeting.

¹ Moderator's Edict (8/6/20): "Brothers, In consultation with the Ad Interim Commission, the LeFebvre Writings Study Committee, Pastor LeFebvre, the Great-Lakes Gulf clerk, and 2nd RP, I, as moderator, am calling a Great-Lakes Gulf Presbytery Meeting for September 11th, 2020 to convene at 12 p.m. at Second R.P. Indianapolis. The specified business for this meeting is the consideration of the LeFebvre Writings Study Committee report and associated recommendations, which will be distributed on or before August 28, 2020. [According to] DoCG 6.4 'A Presbytery may arrange special meetings. The moderator may, at his own discretion, or upon the request of two members, call a meeting to transact business requiring immediate attention. At least ten days' notice shall be given, and the call shall specify the business to be considered. The first decision after the organization of the court shall be on the question of sustaining the action of the moderator in calling the meeting. The presbytery shall consider only the business specified, other items may be introduced by a two-thirds vote." One of the primary considerations in the time & place of the meeting is seeking to address the safety concerns of the presbytery. The meeting will be at 2nd RP, so that we can hopefully meet in a tent outdoors, away from traffic noise; in September hopefully to avoid extreme heat or cold; from 12-5 to avoid the need for serving food and providing overnight accommodations. For those coming from a distance, we will work with the Treasurer so that you can receive reimbursement for meals and necessary lodging. Finally, for those interested, I will lead an informal, outdoor prayer time concerning the issues of this meeting from 10:30-11:30 at 2nd RP on the day of the meeting. In Christ, David Hanson. August 6, 2020"

5. CLERK'S REPORT

Adam Kuehner presented the clerk's report, clarifying that some versions of our Constitution include an obsolete version of Book of Discipline I.3.4-5 (E-4).

- It was moved, seconded, and passed to appoint Phil Pockras and Steve Rhoda as parliamentarians for this meeting.
- It was moved, seconded, and passed to adopt the proposed agenda for this meeting.
- It was moved, seconded, and passed to grant all RPCNA elders present, including all non-certified delegates from this presbytery, the privilege of the floor during the remainder of this meeting.
- It was moved, seconded, and passed to receive the clerk's report.

6. REPORT OF THE LEFEBVRE WRITINGS STUDY COMMITTEE (L.W.S.C.)

- A. <u>OPENING REMARKS</u>: Five minutes was granted to committee chairman, Joel Hart, who then shared a summary of the committee's report.
- **B.** <u>FACTUAL QUESTIONS</u>: Fifteen minutes was granted to the court to ask factual questions of committee; no questions were asked.
- C. <u>RESPONSE FROM MR. LEFEBVRE</u>: Thirty minutes was granted to Michael LeFebvre, who then addressed the court with his response to the committee's report.
- **D.** <u>**DISCUSSION OF THE REPORT</u>**: Thirty minutes was granted to the court for a discussion of the report as a whole. Joel Hart returned to the microphone, and the report was discussed.</u>

BREAK: The court took its first break at 1:05 p.m., after which Bob McKissick reconvened the meeting in prayer at 1:18 p.m.

E. <u>**COMMITTEE RECOMMENDATIONS**</u>: The court turned its attention to the L.W.S.C. recommendations.

<u>RECOMMENDATION ONE</u> (passed)²

The court proceeded to consider Recommendation 1.

MOTION TO SUBSTITUTE (failed, 20-27): It was moved and seconded to entertain a substitute motion,³ as outlined in Communication 20-6.

- The moderator ruled the substitute to be germane, and the mover clarified that it was specifically intended to substitute for Recommendation 1.

² "That an exception to RPT 4.4 be found out of accord with the system of doctrine set forth in the Westminster Confession of Faith, the Larger and Shorter Catechisms, and the Testimony of the Reformed Presbyterian Church."

³ "We acknowledge that Mr. LeFebvre is out of accord with RPT 4.4. We affirm our confidence in Mr. LeFebvre's pastoral ministry as we give more time to seek diligently to win our brother and to evaluate his progress. We seek to win Mr. LeFebvre to the RPCNA's position by appointing a committee of three men to be named by the moderator to work with Mr. LeFebvre over the next three years. The committee will seek input from qualified parties from within and without the RPCNA to engage with Mr. LeFebvre's writings. The committee will actively seek contributions from those who support the RPT 4.4 position, but may also receive submissions from those whose opinions differ. Helpful submissions will be made available to RPCNA elders and contributors. This would allow for robust give and take among contributors as questions are raised. After three years, the committee will lead presbytery in evaluating what the Lord has done and recommend the best course of action for all of the parties."

- Opportunity was given for discussion; no comments were received.
- The parliamentarians clarified the nature of the motion under discussion.
- The motion failed by a vote of 20-27.

MOTION TO AMEND (failed, 22-25): It was moved and seconded to amend Recommendation 1 to replace the word "an" with the words "Mr. LeFebvre's requested".

- The motion was discussed and eventually failed by a vote of 22-25.

<u>RECOMMENDATION 1 (passed)</u>: Discussion of Recommendation 1 ensued, after which it passed.

RECOMMENDATION TWO (amended & failed, 14-29)⁴

The court proceeded to consider Recommendation 2.

<u>AMENDMENT (common consent)</u>: By common consent, the phrase "within 90 days of September 11, 2020" was replaced with the phrase "by December 11, 2020."

MOTION TO CALL THE PREVIOUS QUESTION (failed, 27-17): Following additional debate over Recommendation 2, it was moved and seconded to call the previous question, which failed to reach a two-thirds majority (27-17).

<u>RECOMMENDATION 2 AS AMENDED (failed, 14-29)</u>: Opportunity was given for further comments on Recommendation 2; none were received.

- Recommendation 2 (as amended by common consent)⁵ failed by a vote of 14-29.

<u>RECOMMENDATION THREE</u> (Laid on Table)⁶

The court proceeded to consider Recommendation 3.

⁴ "That the presbytery counsel Mr. LeFebvre to repent within 90 days of September 11, 2020 of the position that this Court has recognized as against the system of doctrine."

⁶ "That Mr. LeFebvre be admonished for failing in his pursuit of the 'purity, peace, unity, and progress of the church' (vow 8) in the process he has followed in his teachings and writings on creation and Adam."

MOTION TO ENTERTAIN A SUBSTITUTE (passed): It was moved and seconded to entertain a substitute motion⁷ for Recommendation 3, after which the motion was discussed.

- MOTION TO CALL THE PREVIOUS QUESTION: It was moved, seconded, and passed by two-thirds majority to call the previous question on the motion to entertain a substitute.
- The motion to entertain a substitute passed, after which the court took up a discussion of the substitute as the main motion on the floor.

<u>POINT OF ORDER (denied)</u>: One of the parliamentarians declared a point of order, noting that the successful motion to call the previous question precludes any further debate on the substitute motion itself.

- The moderator ruled that although the calling of the previous question did rightly preclude further debate on the motion to *entertain* the substitute, it does not preclude further debate on the substitute motion *itself*, which is now the main motion before the court.
- Discussion continued on the main motion.

MOTION TO AMEND (Laid on the Table): It was moved and seconded to amend the main motion by striking charges 1-3.

- The proposed amendment was debated, including a discussion of whether it might be more appropriate for charges to be brought by the movers of the main motion rather than by the court as a whole.
- **BREAK**: By common consent, the court took an additional break at 2:45 p.m., after which Gary McNamee reconvened the meeting in prayer at 2:57 p.m.

^{3.} Violating Ordination Query #8 ("to study and promote the purity, peace, unity and progress of the church") and/or Ordination Query #9 (to "engage to follow no divisive courses from the doctrine and order which the church has solemnly recognized and adopted") by publishing doctrinal teaching which contradicts our belief that the weekly Sabbath is a creation ordinance first instituted by God for the good of all mankind "from the beginning of the world", as articulated in WCF 21.7, WSC 59, WLC 20, and/or WLC 116;

^{4.} ViolatingOrdinationQuery#4("Doyoubelieveinandacceptthesystemofdoctrineandthemanner of worship set forth in the Westminster Confession of Faith, the Larger and Shorter Catechisms, and the Testimony of the Reformed Presbyterian Church, as being agreeable to, and founded upon, the Scriptures?") by holding a personal exception to RPT 4.4, which states "We deny that man evolved from any lower form of life. Gen. 2:7, 21-22".

- **<u>REQUEST TO DIVIDE (granted)</u>**: A request to divide the main motion, so as to isolate each of the four charges, was granted by the moderator.
- **<u>QUESTION OF ORDER</u>**: The court discussed parliamentary procedure with the advice of the parliamentarians, seeking to determine whether the main motion is consistent with BOD II.1.3 (E-9), after which the moderator ruled that the main motion is in order, but that the court is free to lay the present business on the table by two-thirds majority to then entertain a special resolution.

MOTION TO LAY ON THE TABLE (passed, without vocal dissent): It was moved, seconded, and passed without vocal dissent to lay the present business on the table.

7. JUDICIAL PROCESS

SPECIAL RESOLUTION (passed, without vocal dissent)

It was moved and seconded to entertain a special resolution permitting Mr. Kuehner and Mr. Anderson to bring the proposed charges as individual accusers.

- Comments were received regarding the procedural import and necessity of this vote, after which the motion passed without vocal dissent, bringing the special resolution before the court.
- Further discussion ensued, after which the moderator ruled that the court has now received the charges and must proceed to consider the matter of making a written accusation.
- Mr. Kuehner and Mr. Anderson submitted a signed document outlining the charges, which is as follows:

We, the undersigned, do hereby formally charge Mr. LeFebvre with the following censurable offenses:

- 1. Violating Ordination Query #8 ("to study and promote the purity, peace, unity and progress of the church") and/or Ordination Query #9 (to "engage to follow no divisive courses from the doctrine and order which the church has solemnly recognized and adopted") by publishing doctrinal teaching which contradicts our rejection of the theory of human macro-evolution, as articulated in RPT 4.3, RPT 4.4, WCF 4.2, and/or WLC 17;
- 2. Violating Ordination Query #8 ("to study and promote the purity, peace, unity and progress of the church") and/or Ordination Query #9 (to "engage to follow no divisive courses from the doctrine and order which the church has solemnly recognized and adopted") by publishing doctrinal teaching which contradicts our belief that Scripture presents Adam and Eve as the first human beings and sole biological progenitors of humanity, as articulated in WCF 6.1, WCF 6.3, WSC 13, WSC 15-16, WLC 21-22, and/or WLC 26;
- 3. Violating Ordination Query #8 ("to study and promote the purity, peace, unity and progress of the church") and/or Ordination Query #9 (to "engage to follow no divisive courses from the doctrine and order which the church has solemnly recognized and adopted") by publishing doctrinal teaching which contradicts our belief that the weekly Sabbath is a creation ordinance first instituted by God for the good of all mankind "from the beginning of the world", as articulated in WCF 21.7, WSC 59, WLC 20, and/or WLC 116;
- 4. ViolatingOrdinationQuery#4("Doyoubelieveinandacceptthesystemofdoctrineandthemanner of worship set forth in the Westminster Confession of Faith, the Larger and Shorter Catechisms, and the Testimony of the Reformed Presbyterian Church, as being agreeable to, and founded upon, the Scriptures?") by holding a personal exception to RPT 4.4, which states "We deny that man evolved from any lower form of life. Gen. 2:7, 21-22".

Thus, warranting a formal trial — time, place, and special prosecutor to be appointed by the moderator — to determine whether this charge is true, on the basis of the following body of evidence:

WRITTEN ACCUSATION (passed):

At the urging of the moderator, the court proceeded to vote on making a written accusation, in keeping with the steps outlined in BOD II.2.2 (E-10/11).

- **MOTION (passed)**: The motion to classify the alleged offenses as censurable passed.
- **MOTION (passed)**: The motion to regard the proposed evidence as sufficient to warrant a trial passed.
- **MOTION (passed)**: The motion to affirm that Christ's rule in Matthew 18:15-16 has been satisfactorily followed was debated and passed by a vote of 29-17, with Mr. Kuehner and Mr. Anderson abstaining.

BREAK: The court took a break at 3:55 p.m. and reconvened in prayer at 4:07 p.m.

Following the break, it was noted that Adam Kuehner will need to be temporarily relieved as clerk during the upcoming trial, so that he can serve (alongside Shawn Anderson) as a prosecutor in the case.

SPECIAL RESOLUTION (failed, 29-18)

It was moved and seconded to entertain a special resolution: "That presbytery grant Mr. LeFebvre 90 days to study, be counseled, recant, or relocate peacefully with his good name intact."

- **<u>POINT OF ORDER (failed)</u>**: A point of order was raised, asserting this to be a reconsideration of Committee Recommendation 2. The moderator ruled against the point of order and his ruling was challenged unsuccessfully.
- Discussion ensued on whether to entertain the special resolution, after which it failed to reach a twothirds majority by a vote of 29-18.

SPECIAL RESOLUTION (passed)

It was moved, seconded, and passed to entertain a special resolution from the Immanuel RPC Session to request Presbytery to replace the Immanuel RPC Session on the Ad Interim Commission.⁸

- <u>AMENDMENT</u>: The words "to be appointed by the moderator" were added by way of friendly amendment, after which the special resolution passed as amended.⁹

TIME AND PLACE (referred)

The court took up a consideration of the time and place of the impending trial.

- It was moved, seconded, and passed that the time and place of the trial be appointed by the Ad Interim Commission in consultation with the moderator.

8. REPORT OF THE LEFEBVRE WRITINGS STUDY COMMITTEE (L.W.S.C.) — Continued

It was moved, seconded, and passed to take up the L.W.S.C. Report off the table.

⁸ <u>From IRPC Session</u>: "At its regularly scheduled session meeting on September 4, 2020, a motion carried unanimously to request Presbytery to replace the Immanuel RPC Session on the Ad Interim Commission."

- Speaking on the committee's behalf, chairman Joel Hart withdrew Recommendations 4¹⁰ and 5¹¹, and introduced Recommendation 6¹² for discussion.

RECOMMENDATION 6 (ruled out of order)

POINT OF ORDER: Discussion ensued on Recommendation 6, after which a point of order was raised on the basis of BOD II.2.3 (E-11)¹³ asserting that no further actions involving Mr. LeFebvre's case may be taken at this meeting.

- The moderator upheld the point of order, after which a challenge to this ruling failed by a vote of 10-27.

<u>RECOMMENDATION 714</u> (passed)

Recommendation 7 passed without discussion.

It was moved, seconded, and passed to receive the L.W.S.C. Report.

9. POINT OF CLARIFICATION

In response to a question from the floor, the parliamentarians clarified that, per BOD II.2.2, the accusers will be responsible for prosecuting the case and the court will serve as the jury.

- The moderator also noted his belief that the prosecutors would be free to drop any of the charges prior to the trial at their discretion.

10. MOTION TO ADJOURN

It was moved, seconded, and passed to adjourn the meeting.

11. <u>READING OF THE MINUTES</u>

The clerk read the minutes, after which they were approved by common consent as corrected.

12. INTERCESSORY PRAYER & ADJOURNMENT

Rich Johnston led the court in intercessory prayer, followed by the moderator's prayer of adjournment at 5:09 p.m.

¹¹ "That presbytery form a judicial committee to determine a future course of action, depending on the outflow of the 90-day period, and that if Mr. LeFebvre does not repent, the presbytery institute proceedings against Mr. LeFebvre by appointing a special prosecutor to pursue the case & bring charge(s) against Mr. LeFebvre pursuant to the Book of Discipline (2.1.3, E-9 and 2.2.1, E-10). This committee would also be tasked with evaluating Mr. LeFebvre's response to the admonishment concerning vows 8 and 9."

¹² "That during the process of evaluation and judicial analysis, Mr. LeFebvre be directed not to publish written material or speak in public forum (lecture, podcast, etc.) on the issues directly in view of this discussion, namely the origin of Adam and evolutionary approaches to origins."

¹³ <u>BOD II.2.3 (E-11)</u>: "At the meeting in which the accusation is issued no further steps shall be taken, except to fix the time and place of the trial and to summon all who are concerned to appear."

13	Since	the 2020 spring meeting of the Great-Lakes-Gulf Presbytery, the LeFebvre Writings Study Committee
14	has pı	ursued its assigned task. ¹ We began by individually reading all the materials referred to us by the
15	presby	rtery. We also considered various reviews of Mr. LeFebvre's writings, which he provided to us
16	upon	our request. Then, we sent Mr. LeFebvre a series of written questions for clarification on his
17	positio	ons. We met with him on April 11 to discuss those questions. The questions asked to Mr.

28		is presented here is our assessment of the writings as they pertain to the assignment presented to
29		mmittee. We have not sought a point-by-point review of every major topic the writings present.
30		ave we addressed every area of doctrine that could be seen by some as at variance with an
31	interp	retation of our confessional standards. Instead, we have sought to hone in on the issues most

1	pertinent to the questions at hand before us, namely those pertaining to confessional adherence and
2	the ordination vows. Though we explore many areas in the paper, the consideration of Mr. LeFebvre's
3	own stated exception to Reformed Presbyterian Testimony (RPT) 4.4 is embedded in our work from start to
4	finish.
5	
6	Our paper begins by evaluating Mr. LeFebvre's positions on creation and Adam before proceeding to
7	an analysis of issues pertaining to scientific authority. After this, we move to consider Mr. LeFebvre's
8	adherence to the ordination vows, which leads to our proposed answers to Mr. LeFebvre's questions
9	posed in Communication 20-01. We conclude with our recommendations. ³
10	
11	II. An evaluation of Mr. LeFebvre's positions on creation, Adam, and corresponding issues
12	
13	In this section of the paper, we will analyze directly Mr. LeFebvre's positions in view of RPT 4.3 and
14	4.4. Then we will deal more broadly with his views of the creation account, Adam's progenitorship,
15	original sin, and broader covenantal issues, all in view of the question of confessional adherence.
16	
17	In Communication 20-01, Mr. LeFebvre says,
18	
19	I have concluded that my views on the Genesis creation texts involve only one point of actual
20	exception to the RP standards. I am aware that there are at least two other points at which
21	some may perceive additional inconsistencies. As for myself, I only recognize one point of
22	exception to a secondary doctrine in the RP Testimony, and I believe that I am holding that
23	exception consistently with my ordination vows. ⁴
24	
25	Our committee, though, disagrees this assertion of Mr. LeFebvre. Mr. LeFebvre's positions run
26	contrary to not one but several standards of the RPCNA. He allows that some positions affirmed by
27	the standards are possible understandings. However, in many places, he does not affirm the
28	confessional position, except perhaps as allowing the confessional position as a possible interpretation.
29	Instead, Mr. LeFebvre proposes new interpretations that move against the standards. In some cases, he
30	holds that Scripture is entirely silent on a position in the standards – which, by its very inclusion in the
31	standards reveals the church's position that the Scriptures do speak on that subject.
32	
33 24	Reformed Presbyterian Testimony Paragraphs 4.3 and 4.4
34 35	The RP Testimony in paragraphs 4.3 and 4.4 states:
	The NL Testimony in paragraphs 7.3 and 7.7 states:
36

1	4.3 The theory of evolution which assumes that chance happenings are an explanation of
2	the origin and development of matter and living things is unscriptural. God created
3	various kinds of living forms with tremendous potential for variation. The increase of
4	varieties which has occurred is within genetic limitations provided at creation.
5	4.4 We deny that man evolved from any lower form of life.
6	
7	In Communication 20-01, Mr. LeFebvre states his understanding of these paragraphs and where he
8	takes exception to them.
9	
10	Regarding paragraphs 3 and 4 he states:
11	
12	These are the positions we hold, as a denomination, with respect to the theory of evolution. I
13	fully affirm the first of these paragraphs (para. 3) and take exception only to the latter (para.
14	4). ⁵
15	
16	Regarding paragraph 3 he states:
17	
18	I understand that many in our churches likely believe that <i>all</i> forms of evolution are described
19	by this paragraph and would therefore regard paragraph 3 as denying all possibilities of
20	evolution. ⁶
21	
22	Note that later in the very same paragraph, we actually affirm that some processes of
23 24	evolutionary change do occur "within [the] genetic limitations provided [by God] at creation."
24 25	Since the very same paragraph acknowledges some forms of evolutionary processes in nature, the earlier statement cannot be read as a blanket characterization of all theories of evolution
23 26	Therefore, it does not appear to me that paragraph 3 requires an opposition to all processes of
20 27	evolution, but only to those theories which assert evolution as sufficient to account for all that
28	exists (i.e., to the neglect of God). ⁷
20	exists (i.e., to the neglect of God).
30	If my understanding of paragraph 3 in this manner is deemed permissible by this court, then I
31	find no reason to assert any exception to it. As far as I can reflect on my own heart, and with a
32	clear conscience toward God, I fully affirm RPT 4.3. ⁸
33	
34	And regarding paragraph 4 he states:

1 It is to paragraph 4 that I find I must take exception. This is the paragraph wherein we, as a

- 2 church, "deny that man evolved from any lower life form." For reasons detailed in my paper,
- 3 "Adam Reigns in Eden," I do not find that Scripture supports this denial. But neither do I
- 4 believe that Scripture asserts the contrary. Scripture is silent on such natural processes as
- 5 evolution, and so I do not think it proper to make a theological statement of faith either
- 6 affirming or denying evolution. I do, therefore, take exception to RPT 4.4.

That being said, I fully appreciate and heartily affirm what I suspect to be the underlying
intentions behind that paragraph's denial. I suspect that the real targets of paragraph 4 are the
assertions that are often joined to atheistic claims about human evolution: for instance, that
humanity is not in the image of God, or that God did not create humankind.⁹

11 Concerning Mr. LeFebvre's Position on RP Testimony Paragraph 4.3

12 Mr. LeFebvre claims to "fully affirm" paragraph 4.3. His assessment is that paragraph 3 only rejects

13 those views of evolution that rely on "chance happenings" (actual undirected chance). However, we

14 note that the reference in the RP Testimony to the creation of kinds excludes virtually every view of

15 evolution accepted by the majority of evolutionists. It states, "The increase of varieties which has

16 occurred is within genetic limitations provided at creation." Nine times Genesis 1 tells us that each

- 17 type of living creature reproduces "according to its kind". It is not true that living creatures evolve from
- 18 one kind to another.
- 19 Mr. LeFebvre asserts that "we (i.e., the RPCNA) actually affirm that some processes of evolutionary
- 20 change do occur 'within [the] genetic limitations provided [by God] at creation'". However, we believe

21 it is misleading to even give the impression that affirming variation within the God-appointed kinds

22 somehow allows the possibility of evolution from one kind to another. It is precisely this sort of

evolutionary development that is in question with Mr. LeFebvre's questioning of RPT 4.4 of the

- 24 Testimony. Therefore, to teach that kinds do evolve to higher kinds, or that it is even possible (within
- the bounds of Scripture) that kinds evolve into higher kinds, is effectively contrary to RPT 4.3.
- 26 In addition, in *The Liturgy of Creation*, Mr. LeFebvre asserts that "the uncritical acceptance of the
- 27 atheistic claim that Genesis is incompatible with evolution must be rejected."¹⁰ Since RPT 4.3 appears

to claim that Genesis is incompatible with the commonly-accepted view of evolution, this statement

29 appears to be rejecting the Testimony at this point. At the very least, such an assertion moves far afield

30 from RP Testimony 4.3.¹¹

- 1 Concerning Mr. LeFebvre's position on RP Testimony Paragraph 4.4
- 2 Mr. LeFebvre explicitly claims an exception to this paragraph and states that it "is a secondary point of
- 3 doctrine (i.e., that it is not systemic under query four)".¹² He argues that Scripture does not support the
- 4 paragraph of the *Testimony* and that by taking exception to it he is not saying that Scripture teaches that
- 5 man did evolve from a lower form of life, but simply that "Scripture is silent on such natural processes
- 6 as evolution."¹³
- 7 By taking exception to the denial of RPT 4.4., he is saying that it is possible that man (i.e. mankind)
- 8 did evolve from a lower form of life, just not by chance, but rather in a God-directed way, and that
- 9 Scripture, being silent, allows the possibility.
- 10 However, Scripture is not silent on natural processes. By declaring that each kind reproduces according
- 11 to its own kind Scripture has declared that evolution from one kind to another is not possible. The
- 12 teaching of Genesis 1 is that each kind of creature is distinct from the others (although they share
- 13 many common properties and processes) and that they do not evolve from one kind to another.
- 14 It is especially the teaching of Scripture that man is a unique creation of God, or of a "kind" distinct
- 15 from the animal "kinds". The Confession affirms this when it states, "After God had made all other
- 16 creatures, He created man, male and female..." (4.2). The same teaching is affirmed by the *Larger*
- 17 Catechism Q. 17. The Confession and Catechism both assert that it is the teaching of Scripture that
- 18 mankind was not formed by any process other than by the direct hand of God, Adam from the dust of
- 19 the ground, and Eve from Adam.¹⁴
- Thus, to take exception to paragraph 4.4 of the *Testimony* is contrary to paragraph 4.2 of the *Confession* and Q17 of the *Larger Catechism*.¹⁵
- Already, at this point, the relation of RPT 4.4 to the broader denominational standards is being
- revealed. Now, broader points need to be observed about Mr. LeFebvre's writings and positions on
- creation, Adam and Eve as progenitors, and covenant headship and original sin.
- 25 Regarding Mr. LeFebvre's Writings on the Genesis Account of Creation

- 1 In The Liturgy of Creation, concerning the creation week, Mr. LeFebvre writes: 2 It participates in the law-giving function of the Pentateuch and serves as another of the 3 calendar narratives designed to bring God's work to bear on Israel's metronome of labor and 4 worship in the land. The dates do not reflect original occurrence timing but rather later Israel's 5 legally instructed observance timing. This approach to the creation week accords with the 6 Pentateuch's own representation of that narrative in the fourth commandment of the Decalogue..."16 7 8 At this point, he quotes Exodus 20:8-11. Later, Mr. LeFebvre reaffirms much the same position, saying: 9 I want to show that the creation week is another of the Torah's calendar narratives. Genesis 10 1:1-2:3 provides a narration of creation events, but the timing and details of its telling are 11 transparently "re-mapped" to the cadence and themes of Israel's weekly sabbath festival. The 12 purpose of the narrative is not simply to teach the people what happened but to teach them 13 how to remember God's work and God's rest through their own weekly labors and worship. 14 This is, in fact, what the fourth commandment identifies as the creation narrative's function.¹⁷ 15 His argument is that the creation account of Genesis is "remapped" to (i.e., based upon) the weekly 16 Sabbath later instituted by God for Israel and was intended primarily to remind the people of their 17 obligation to keep the weekly Sabbath. 18 But in Exodus 20, the opposite of Mr. LeFebvre's reasoning is given. Scripture does not say that 19 because the people of Israel were to keep the weekly Sabbath that therefore God's creation is described 20 as happening in six days with a seventh day of rest. The account of creation is given as the basis of the 21 weekly Sabbath - man's call for six days then rest derives from God's own pattern. As quoting the 4th 22 commandment, Larger Catechism answer 115 and Shorter Catechism answer 57 accord with the 23 Scriptures in affirming Sabbath-keeping as based on God's actual example, and not the inverse.¹⁸ 24 On the broader point here of Genesis and history, RP Testimony 4.1 states: "The account of creation in 25 Genesis 1 and 2 is history, not mythology." 26 Doubtless, Mr. LeFebvre has not stated an exception to *Testimony* paragraph 4.1 since he would agree 27 that Genesis 1 and 2 are not mythology. But his framing them as an idiomatic description of events 28 based on God's later prescriptions for Israel presents real question as to how Genesis 1 is being treated 29 as historical. To say that the creation account of Genesis is not offering a historic,
- 30 chronologically-based account is contrary to the *Testimony* and the *Catechism*.

One last point on the creation account needs to be made. In GLG paper 20-01, regarding *Testimony* paragraph 4.1, Mr. LeFebvre says:

3 I fully affirm this statement within the parameters expressed by synod in 2002. In that 2002 4 ruling, synod recognized that the Westminster divines, themselves, almost certainly regarded 5 the six creation days as the actual timing of the creation event. However, synod also recognized 6 "that differing views of the length of these days are held by some in the church" and that these 7 "variant views ... have hitherto not been the ground of either denying ordination or instituting 8 discipline." Furthermore, synod positively urged, "that the best answer to this situation [i.e., 9 the presence of controversy in the church over the nature of the creation days is for us to 10 resolve, in the Confession's own language, to let 'the Holy Spirit speaking in the Scripture' be the supreme judge of any controversy in this matter, in the context of ongoing ministry that 11 seeks to be biblically and confessionally faithful before the Lord."¹⁹ 12

13 By Mr. LeFebvre's admission, the *Confession* almost certainly meant "the actual timing of the creation

event". To suggest that it means something other than that would tend to discount the original authors of the Confession.

- 16 Regarding Mr. LeFebvre's Writings on Adam and Eve as the Progenitors of the Human Race
- 17 In the introductory section of Adam Reigns in Eden, Mr. LeFebvre writes:
- 18 It is now regarded as genetically improbable—some insist, impossible—for the human race to 19 have arisen from a single couple. ... the human race embodies remarkable genetic diversity that, 20 according to the operations of genetics, cannot be explained by a single set of parents.²⁰
- 21 On the contrary, the human race embodies remarkable genetic diversity that, according to the 22 operations of genetics, cannot be explained by a single set of parents.²¹
- All sides of the discussion generally concur on one point: the Adam narrative is an origin story
 (an etiology) for the human race. But is it, in fact, this point of consensus that needs
 correction?²²
- 26 Adam is introduced as humanity's first father, not in his reproductive capacity but in his royal
- 27 appointment. The thesis of this paper is that the Eden narrative introduces Adam as
- 28 humankind's first king, and the narrative is an etiology of kingship with only tangential
- 29 relevance at best to the question of humankind's biological origins. Consequently, current

genetic findings have no bearings on the question of Adam's historicity. He was a real person
 who was appointed by God as humanity's first universal king, but—as we will examine in this
 paper—the Genesis text does not actually require that Adam was the sole progenitor of all
 subsequent human beings.²³

5 Regarding Adam as humanity's first universal king is not necessarily exclusive of the view that 6 Adam may also have been the first human being and progenitor of the whole human race. ... 7 Any implications of the text for human ancestry is secondary at best. While this conclusion is 8 nuanced differently from the traditional view, it is not inconsistent with orthodox soteriology. 9 In fact, the likeness of Jesus to Adam is based on their like role as federal heads of humankind, 10 not paternity. It is regency rather than reproduction that, in Pauline thought, links the First and Second Adams. Jesus never begat biological offspring. Jesus is the Second Adam strictly by 11 his succeeding the First Adam in his role as humankind's universal king (Rom. 5:12-21).²⁴ 12

It is my contention that the Eden narrative (Gen. 2:4-4:26) is an etiology of kingship, not
 human biological origins.²⁵

15 Key parts of his thesis include:

- That there was a single set of parents is genetically improbable and the diversity we see in the
 human race cannot be explained by a single set of parents.
- That Adam may have been the first human being, but it was not the purpose of Scripture to say that or to explain human biological origins.

In fact, that Mr. LeFebvre does not believe that immediately after Adam and Eve were created, they were the only humans on earth, or that the human race descended from a single set of human parents is confirmed later in the article when he writes:

23 Remarkably, the narrative presupposes the presence of other populations already dwelling to 24 the east of Eden! Up to this point in the narrative, it is possible to regard Adam as the first king 25 and also humanity's first progenitor. It is only as the narrative follows Cain away from Eden into "the land of wandering" that we realize the author's worldview includes other populations 26 already present. Questions like, "Where did Cain get his wife?" (4:17) and "Who were the other 27 28 people Cain was afraid would kill him when he was cast out?" (4:14) and "Who lived in the city 29 built by Cain?" (4:17) have been asked for centuries. Typically, these questions have been 30 viewed as marginal issues mainstream exegetes answered by postulating extreme fecundity to 31 Eve (cf., 5:4). However, in light of current questions about Adam's biological relationship with 32 the rest of the human race, those peripheral details about other populations contemporaneous 33 with his household may be much more important than previously recognized. Walter Moberly

- notes that the text's presupposition of a populated world is actually pervasive through the text,
 beyond the most obvious instances connected with Cain's exile.²⁶
- A broader population is assumed throughout the Eden narrative, although it is clearest when Cain is banished to the lands of the east, where he fears attack, finds a wife, and founds a city. ... In particular, banishment to the east was a punishment for Cain. Are we to suppose that other sons and daughters of Adam had been exiled to that distant "land of wandering" prior to Cain? Had large numbers of other sons and daughters of Adam previously been exiled for earlier crimes like that leading to Cain's banishment? It seems that the narrative simply presupposes there are other, non-settled groups of wanderers "out there."²⁷
- 10 Ultimately, any effort to use the Bible to explain the origins of those among whom Cain settled 11 must lean on arguments from silence. The text presupposes the existence of dangerous 12 populations of wanderers in the east without explaining them. That is significant. It is not part 13 of the writer's agenda to report the origins of those other populations! The Augustinian 14 interpretation inserts assumptions into the text. So do other efforts to explain the origin of 15 those peoples It is not possible to make any assertions from Scripture as to where Cain's 16 contemporaries came from. Genesis is silent on that question. Thus, we can reliably conclude 17 that Genesis 2:4-4:26 was written to address a different topic than the origins of all human 18 populations. The question of human biological origins is not the burden of the passage. The 19 origin of all humanity is the burden of a passage in the previous chapter: Genesis 1:26-27. That 20 text reports that God created humankind in the categories of "male and female" by his 21 command. But the Eden narrative tells a different story. And the Eden narrative occurs at a 22 time when humankind was already greater than a single family, since the text presupposes a 23 broader population than Adam's household without any concern to explain their identity or relationship to him. The etiological function of the Eden narrative is one of kingship and not 24 genetic origins.²⁸ 25
- In this essay, it has been argued that Adam is introduced as the first universal king and not the
 first progenitor of humanity.²⁹
- 28 Key parts of his thesis include:
- Scripture actually presupposes there were other humans present at the time the events recorded
 regarding Adam and Eve took place.
- That must have been the case in order to be able to understand the account of Cain's concern over being killed and even his ability to find a wife.

- 1 Five exegetical considerations arise that challenge Mr. LeFebvre's thesis.
- 2 First, Mr. LeFebvre's thesis overlooks the long lives of Adam and Eve and their descendants (some over
- 3 900 years). In this timeframe, they could have very easily have produced thousands upon thousands of
- 4 descendants. It is reasonable to assume that Cain would very likely come in contact with many of his
- 5 "cousins" who might seek revenge for the killing of Abel, and also many from which he could have
- 6 taken a wife. Nothing in the account describes how many years passed before Cain killed Abel, which
- 7 quite likely occurred, as Mr. LeFebvre states, "at a time when humankind was already greater than a
- 8 single family" (but not for the reasons Mr. LeFebvre assumes). Nothing in the account requires other
- 9 humans to have been created by God from whom God chose Adam and Eve for special roles.
- 10 Second, Mr. LeFebvre has moved against a faithful, confessional clear reading of Genesis 2:7-8.³⁰ The
- 11 Confession makes reference to the creation of man in WCF 4.2: "After God had made all other
- 12 creatures, He created man", with Genesis 2:7 being listed as a cited prooftext. What the confession
- 13 speaks of here in interpreting Genesis 2:7 is the creation of a man (Adam) and not any kind of
- 14 coronation of a king or other like event. This guides an interpretation of the Genesis 2:7 impartation
- 15 of the breath of life into Adam as a creation, or an immediate act that separated Adam from the
- 16 creatures. To argue otherwise is contrary to Scriptural interpretation and to the standards.³¹
- 17 Third, if, as Mr. LeFebvre postulates, there was a broader population of humans at the time Adam was
- 18 placed in the garden, Genesis 2:18 and 2:20 would suddenly present an exegetical conundrum. There,
- 19 God says, "'It is not good that man should be alone; I will make him a helper comparable to him.'"
- 20 (Genesis 2:18). In Genesis 2:20, it says, "for Adam there was not found a helper comparable to him"
- 21 (Genesis 2:20). Thus, God proceeded to form Eve from the very body of Adam. If God could single out
- Adam from a mass of human males to raise to kingship, why not a woman from a mass of human
- 23 females to raise to queenship as a wife for Adam?
- 24 Fourth, throughout Adam Reigns in Eden, Mr. LeFebvre teaches that Adam was "raised from the dust of
- the ground" signifying his being raised to "king".³² This reading, however, presents exegetical conflict

- 1 with Genesis 3:19. Genesis 3:19 reads, "In the sweat of your face you shall eat bread till you return to
- 2 the ground, for out of it you were taken; for dust you are, and to dust you shall return." Adam was
- 3 made from the dust of the ground and Eve from him. If in Genesis 2:7 "formed man of the dust of the
- 4 ground" means being raised to kingship, to what does the return to dust of Genesis 3:19 refer? The text
- 5 clearly speaks to the death of the body followed by decay in the dust. It does not mean that one ceases
- 6 to be king, which is what Mr. LeFebvre's thesis would require.

7 Fifth, Mr. LeFebvre has capitulated to the understanding of some regarding the "operations of

- 8 genetics" that requires many pairs (hundreds or even thousands) of biological parents for the present
- 9 diversity seen in the human race. But this goes contrary to Scripture when in Genesis 7-9 recounts only
- 10 eight humans entering the ark. The same interpretation is found in 1 Peter 3:20 and 2 Peter 2:5.
- 11 Therefore, Scripture teaches that the entire population of humans on earth from that time forward are
- 12 descendants of Ham, Shem and Japheth and their wives, not many or even thousands of pairs of
- 13 humans. This unexplained tension in Mr. LeFebvre's writings runs contrary to Scripture.
- 14 With this in mind, we can list the places in the Confession and the Testimony that teach that Adam and
- 15 Eve were the original and only humans (directly created by a special act of God). We have already

16 noted WCF 4.2, which is corroborated by WLC 17 on this point. In addition, the Confession, in

17 paragraph 6.3, says, "They being the root of all mankind...". The "they" referred to are Adam and Eve.

18 To teach that Adam and Eve are not the "root of all mankind" is contrary to the Confession.

- 19 Other confessional statements speak to the language of "our first parents:"
- Our first parents, being seduced by the subtilty and temptation of Satan, sinned in eating theforbidden fruit. (WCF 6.1)
- Our first parents being left to the freedom of their own will, through the temptation of Satan,
 transgressed the commandment of God, in eating the forbidden fruit, and thereby fell from the
- 24 estate of innocency wherein they were created. $(LC 21)^{33}$
- 25 The expression "our first parents" refers to Adam and Eve. To imply that "first" has others that
- 26 preceded them in some way, or were contemporaneous with them, and from which some of modern-
- 27 day mankind has descended, does injustice to the plain meaning of the word "first".³⁴

- 1 These paragraphs also make no sense if some of us today (implied by the word "our") were not the
- 2 biological descendants of Adam and Eve and to teach otherwise is contrary to the Confession and the
- 3 Catechisms.
- 4 As we contemplate this theme of Adam's progentiorship, we discover what is perhaps the underlying
- 5 cause of discord with the confessional standards on this point. For Mr. LeFebvre, the Eden narrative is
- 6 a "different story"³⁵ than that of Genesis 1:26-27, and issues of human biological origins are not in
- 7 view of Genesis 2, as perhaps they are in Genesis 1.
- 8 And yet, the Confession and Catechism assume that Genesis 1 and 2 refer to the same event. WCF 4:2
- 9 combines the creation of man in God's image (referring to Genesis 1) with the creation of their
- 10 "reasonable and immortal souls", with Genesis 2 given as the prooftext there. Larger Catechism 17
- 11 combines the creation of man male and female (interpreting Genesis 1) with the Genesis 2 language of
- 12 the formation of the "body of the man from the dust of the ground and the woman of the rib of the
- 13 man". The Confession and Catechism assume that Genesis 1 and Genesis 2 both refer to the etiology of
- 14 mankind. To assert otherwise is contrary to the standards.
- 15 Ultimately, on this entire subject of the origin of mankind and the progenitorship of Adam and the
- 16 origin of mankind, to remain within the confessional bounds, what must be maintained is the
- 17 announcement of Genesis of the immediate creation of Adam as the first of mankind. By this we
- 18 mean, to use A. A. Hodge's description: "That man, on the contrary, was immediately created by God,
- 19 his body out of earthly materials previously created and his soul out of nothing."³⁶ To move against this
- 20 is to move against the pervasive teaching of the confession.³⁷

- 1 Regarding the Relationship between Mr. LeFebvre's Positions and Questions Concerning Adam as the Covenant
- 2 Head and Original Sin
- 3 In 20-01, Mr. LeFebvre writes:

4 [On WCF 6.3] In that article [Adam Reigns in Eden], I argue that the Eden narrative presents 5 Adam as humanity's first (and failed) universal king in the same manner in which Jesus is 6 humanity's second (and continuing) universal king. There is, of course, nothing controversial 7 there. But I also note evidence within the Genesis account that suggests the passage is 8 concerned with Adam's fatherhood as humanity's federal head without necessitating that 9 Adam be the biological father of all humans as well—such as the presence of contemporaneous 10 populations east of Eden (Gen. 4:14-17) without any effort by the author to explain their relationship to Adam. ... While admittedly controversial, I do not believe these considerations 11 12 bring me into contradiction with our standards. It is my understanding that phrases like "root of all mankind" and "first parents" are used in WCF 6.3-and throughout the Westminster 13 Standards-to identify Adam's federal office, which is precisely what my work affirms. I 14 15 understand that these terms are generally understood to reflect Adam's biological fatherhood 16 of all humanity, also. However, that physical link is not the theological burden of these references in the Confession and Catechisms.³⁸ 17

- [On WCF 6.3] Most of the reformers (and most if not all of the Westminster divines) likely did
 hold that Adam was the biological ancestor of all humankind as well as humanity's first
 covenant head. However, the reformers held that original sin is communicated due to Adam's
 office, not through the mechanism of physical generation.
- Again, I readily admit that the reformers generally maintained as a historical given that Adam 22 23 was the first father of the whole human race. However, the doctrine of original sin was 24 explicitly decoupled from physical descent as a mechanistic necessity, even leading to the 25 general rejection of traducianism. Original sin is transmitted to all humankind by imputation 26 due to Adam's covenantal office (not by impartation through generational descent), just as 27 justification is transmitted by imputation due to Christ's covenantal office (not by impartation 28 through the sacraments). ... Both the sin and the righteousness presuppose a federal relation between humanity as a whole and its heads."³⁹ 29
- IOn WCF 6.3] As I understand the theology of Adam's federal headship: it is already woven
 into the fabric of covenant theology that, while Adam might be regarded as the physical father
 of the entire human race, neither the universal import of his fall nor the doctrine of original

sin and universal human guilt are dependent upon that physiological connection. And if it were to be found that the Scriptures do not present Adam as the sole progenitor of the human race, he would still remain the "first man" and "root of all mankind" by virtue of his covenant appointment—just as Jesus, though never having born children, is called "Everlasting Father" (Isa. 9:6) and the "root of David" (Rev. 5:5)—and the doctrines of the fall and original sin

6 would remain unchanged.⁴⁰

7 Key points of his thesis include:

- Adam's fatherhood as humanity's federal head does not require that Adam be the biological
 father of all humans as well.
- The phrases "root of all mankind" and "first parents" identify Adam's federal office and a
 physical link is not the theological burden of these references in the confessional standards.
- The doctrine of original sin is explicitly decoupled from physical descent as a mechanistic
 necessity such that neither the universal import of his fall nor the doctrine of original sin and
 universal human guilt are dependent upon that physiological connection.

However, the Confession in paragraph 6.3 says "They being the root of all mankind, the guilt of this sin was imputed, and the same death in sin and corrupted nature conveyed, to all their posterity descending from them by ordinary generation." This clearly establishes a link between the guilt of original sin and the posterity of Adam and Eve – and to clarify that it added "descending from them by ordinary generation". The clear teaching of the Confession is that the guilt of original sin is imputed only to the physical descendants of Adam and Eve. The Confession allows no room for the guilt of original sin to be imputed (by covenant) to any other supposed contemporaneous humans.

Many other sections of the *Confession*, *Testimony* and *Catechisms* contradict Mr. LeFebvre's thesis regarding original sin and covenant representation.:

- Confession 7.2: "The first covenant made with man was a covenant of works, wherein life was
 promised to Adam, and in him to his posterity, upon condition of perfect and personal
 obedience.". Here we see that life was promised to the "posterity" of Adam, not to anyone else.
 The word "posterity" does not mean those "in covenant with him". It means those "descending
 from him".
- *Testimony* 7.1: "We reject the teaching that Adam was not a covenant head and representative of all his descendants." This paragraph says that Adam was the "covenant head and representative of all his descendants". If he could also be the "covenant head and representative" of more than his descendants, why does it not say that? The implication is that we are not to believe that he was the covenant head and representative of anyone else.
- Larger Catechism 22: "Q. Did all mankind fall in that first transgression? A. The covenant being
 made with Adam, as a public person, not for himself only, but for his posterity; all mankind

descending from him by ordinary generation, sinned in him, and fell with him in that first
transgression."⁴¹ The answers to WLC 22 and WSC 16 say that the covenant was made with
Adam and his posterity. And, the answers explicitly define who those were: "all mankind
descending from him by ordinary generation." Therefore, to teach that the covenant might
have included (or did include) others not descending from him by ordinary generation is
contrary to the teaching of the catechisms.

7 Larger Catechism 26: "Q. How is original sin conveyed from our first parents unto their posterity? A. 8 Original sin is conveyed from our first parents unto their posterity by natural generation, so as 9 all that proceed from them in that way are conceived and born in sin." The answer to this question teaches that original sin is conveyed from our first parents (Adam and Eve) to "their 10 posterity by natural generation", "all who proceed from them in that way". It further teaches 11 that "their posterity by natural generation" and "all who proceed from them in that way" are 12 13 the ones who are conceived and born in sin. Nothing is said about how that comes about, but it is clear that it is teaching that it is only to "their posterity by natural generation" and "all who 14 15 proceed from them in that way". To teach that original sin is conveyed to anyone else is 16 contrary to the teaching of the Larger Catechism.

17 Conclusion to Section 2⁴²

18 Mr. LeFebvre contends that he takes exception to only paragraph 4.4 of the RP Testimony. However,

19 this exception necessarily creates conflict with many other areas of the Confession, Testimony and

20 Catechisms. Other statements concerning creation and Adam may not have a necessary dependence on

21 affirming RPT 4.4, but Mr. LeFebvre's views on creation have run contrary to these statements

22 nonetheless. We summarize below the list of confessional statements on creation and Adam that we

23 find in conflict with Mr. LeFebvre's views:

III. An underlying issue: Mr. LeFebvre's approach to scientific authority

Beyond the specific question raised in Communication 20-01 concerning the confessions and RPT 4.4, the committee has noted many other issues raised in various communications forwarded to it by the presbytery and received directly from various interested parties.⁴³ Most of these collect around the larger issue of the relationship between scriptural authority and science. The theme of how to characterize this relationship is familiar to students of recent church history and formed a core area of concern in the modernist debates in mainline Reformed and Presbyterian churches in the first half of the 20th century, and in later developments in more orthodox churches in the subsequent decades.

- Indeed, the communications to the presbytery make reference to the slide of various denominations into theological liberalism, connecting Mr. LeFebvre's writings to these earlier controversies.
- 13

14 Our committee has not necessarily come to an agreement concerning our common judgment about

15 many questions regarding Mr. LeFebvre's treatment of specific passages, but we do agree that a larger 16 issue appears to be driving many of the conflicts over the writings. This is the nature of scientific

17 authority, and how it constrains and drives the interpretation of scripture.

18

19 Scriptural Authority vs. Scientific Authority

20

21 Concerning the authority of scripture, our church's confessional statements are very clear on many

22 points, including the doctrines of inerrancy and infallibility (RPT 1.13), and concerning the plenary

23 inspiration of scripture in its inception and our understanding of the nature of scriptural authors and

how to interpret scripture (WCF 1.9 – 1.10; RPT 1.5 – 1.8, RPT 1.19). Included in these confessional

25 statements is a clear statement of the scope of scriptural authority as encompassing all of life and

- doctrine. RPT 1.13 states "We reject the view that the Bible is only partially inspired, that inspiration
- 27 pertains only to 'revelational' matters or 'saving' truth ...", or to put it another way, where the Bible
- 28 speaks to an issue, it is inspired. Thus, scriptural authority potentially encompasses any and all aspects

29 of physical creation.

1	
2	Our discussion with Mr. LeFebvre on this topic has been aided by the Chicago declaration, a statement
3	formulated by the International Council on Biblical Inerrancy to draw together orthodox Christians
4	from various denominational backgrounds with a common concern for upholding the doctrine of
5	scripture. Among its signatories were many leaders across the RPCNA. Particularly relevant to the
6	current situation are articles 4 and 5 of the shorter declaration, and the denials in the attendant
7	Articles XII and XIII.
8	
9	4. Being wholly and verbally God-given, Scripture is without error or fault in all its teaching, no less in what it
10	states about God's acts in creation, about the events of world history, and about its own literary origins under
11	God, than in its witness to God's saving grace in individual lives.
12	
13	5. The authority of Scripture is inescapably impaired if this total divine inerrancy is in any way limited or
14	disregarded, or made relative to a view of truth contrary to the Bible's own; and such lapses bring serious loss to
15	both the individual and the Church.
16	
17	Article XII. We deny that Biblical infallibility and inerrancy are limited to spiritual, religious, or redemptive
18	themes, exclusive of assertions in the fields of history and science. We further deny that scientific hypotheses
19 20	about earth history may properly be used to overturn the teaching of Scripture on creation and the flood.
20	And I WIII We down that it is truct on the surger Society on a second on the standard of the share of the second
21 22	Article XIII. We deny that it is proper to evaluate Scripture according to standards of truth and error that are alien to its usage or purpose. We further deny that inerrancy is negated by Biblical phenomena such as a lack
22	of modern technical precision, irregularities of grammar or spelling, observational descriptions of nature, the
23 24	reporting of falsehoods, the use of hyperbole and round numbers, the topical arrangement of material, variant
25	selections of material in parallel accounts, or the use of free citations.
26	seccions of matchai in parader accounts, of the use of free clations.
27	In our discussion, Mr. LeFebvre himself pointed to the Chicago statement as a standard of inerrancy to
28	be guided by.
29	
30	Concerning scientific authority, we note first of all that the confessions of the church are much less
31	well developed than they are concerning Biblical authority. RPT 1.1 indicates that God reveals Himself
32	clearly, minus his covenantal purposes, through all his works, calling this revelation <i>Natural or General</i>
33	Revelation. Most treatments of the question of scientific authority tend to base it in the notion of
34	General Revelation, discussing these two methods of revelation, e.g. as laid out in RPT 1.1, as
35	indicating two methods of ascertaining God's truth. Science, in such treatments then, pertains to
36	ascertaining truth through General Revelation. The strength of this approach is that it grounds all
37	truth in God's revelation of Himself and what He is doing in creation, providence, and redemption, so
38	the approach leads the church away from a fragmented view of reality towards an integrated view of
39	faith and life as flowing from Christ who is the Word Incarnate.
40	
41	A potential problem with some attempted practical applications of the dual revelation formulation,
42 43	however, is a tendency of seeing scriptural revelation and scientific inquiry as being somehow parallel. This tends, then, to encourage us to ascribe aspects of the administration of Special Revelation to

43 This tends, then, to encourage us to ascribe aspects of the administration of Special Revelation to

Page 30 of 51

General Revelation, for example, by giving scientists credentials as prophets (or ordained preachers) of General Revelation. RPT 1.2, then, reminds us that obscurity in general revelation can exist, and it is due specifically to the natural limitations of humanity, and particularly the sinfulness of mankind.
Beyond this, the confessions of the church do not speak directly to the nature of science itself, so the stance of the church with respect to the nature of scientific authority is not explicit at this time. We will lay out some of our understanding immediately below, and then go on to discuss how we see it interacting with Mr. LeFebvre's writings.

8

9 The two types of revelation, *special* and *general*, are not entirely parallel. Special Revelation is a

- 10 particular providence within the general activity of God revealing himself to people. The term, *special*,
- 11 in Special Revelation denotes two things, first, that it is *specific*, and second that it is *explicit*.
- 12

13 It is *specific*; it does not impart knowledge about everything, but it targets some things and not others.

14 God does not target all of our understanding of His ways with Scripture; He selects particular things to

15 communicate and correct through the word, and not other things. Since God is the creator and

16 sustainer of everything; scriptural authority is not limited in its scope; it is limited only by God's intent

17 to redeem *specific* parts of his people's minds. He does not choose to redeem every part of our

18 individual minds through the Word at this time but leaves parts of the human mind to be ministered

19 to by the common operations of the Holy Spirit, outside of the Word. However, there is no reason to *a*

20 *priori* define and delimit which aspects of creation and providence the scriptures can address with

authority. We have no reason to expect that our attempts to do so, leaving some world of autonomous

22 authority outside of the Scriptures, will be successful. Scriptural revelation and authority speak broadly

and specifically to all categories of life, and attempting to delimit the practical scope of its authority

24 away from fields addressed by science will be unsuccessful and potentially destructive.

25

26 Special Revelation is also *explicit*. By communicating through Scripture, God by His Spirit addresses the

27 human mind directly. This mode of communication differs from what takes place in General

28 Revelation, where communication is mediated by creation and providence itself. Scientific investigation

does not yield explicit accounts of the nature of creation, but people construct accounts based on the

30 experienced nature of creation and God's acts of providence. While we also construct accounts and

doctrine on the basis of Scripture in a similar fashion, scriptural revelation is fundamentally different

32 from general revelation in that scriptural accounts are explicit by their very nature.

33

34 Scientific endeavor observes creation and providence and then applies human reason to such

35 observations. Scientific endeavor, then, is limited by our ability to observe the targets of our study and

36 is also limited by our ability to reason our way to the nature of things. There are surely many things

37 outside of our ability to observe, including events in the distant past and the future. These limitations,

then, restrict how and the degree to which the human mind can grapple with various topics. The

degree to which these topics are distant from us in time, space, or scale, will determine the degree to

40 which we are capable of saying anything to any particular topic. There are also many things that are not

1 subject to the simple grasp of human reason. For example, scientific inquiry focuses on, and one might

- 2 even say, is restricted to generalizable and replicable phenomena. Scientific reasoning deals in
- abstraction. What this means is that events that do not repeat or are otherwise unique are not
- 4 capturable with the scientific method. In addition, scientific inquiry is, like all human endeavor,
- 5 plagued with the effects of sin, marred by our unwillingness to observe with rigor, to admit
- 6 observations that do not fit with our preconceptions, and warped by our biases toward particular
- 7 models or conclusions. Science never holds a claim to explicit and inviolable truth, but needs to rely
- 8 upon persistent, healthy skepticism, as all accounts need to be persistently held to the standards of the9 observation of creation.
- 10

11 Scientific Authority in Mr. LeFebvre's Writings

12

13 Turning to Mr. LeFebvre's writings, we note that interaction with scientific authority, while not driving 14 much of the actual textual content of The Liturgy of Creation or "Adam Reigns in Eden", occupies a very prominent position in both works in terms of how the writings are situated in the larger discourse. The 15 summary 12th chapter of *The Liturgy of Creation* is dominated by two themes. The first is the 16 Biblically-oriented point that the creation narrative in Genesis 1 emphasizes God's structuring of time 17 18 in the establishment of the sabbath. The second is a philosophical and practical concern that 19 Christians need to learn to trust science. On page 211, he argues that Christians need to learn to 20 engage with science regarding issues ranging from origins to vocation to health care using the fallible 21 tools of science. Page 209 contains a litany of areas in which Mr. LeFebvre decries the aversion of many 22 American Christians to various points of scientific doctrine. We also note that several reviewers' 23 statements of disapproval of The Liturgy of Creation specifically reference this section of the book. Most of the textual analysis of Genesis 1 in The Liturgy of Creation stands without reference to this theme in 24 25 the 12th chapter. While many may not agree with any or all of the textual analysis in the book, it is 26 clear that the nexus between his analysis and this statement of purpose developed in its 12th chapter is 27 greatly contributing to the conflict over the book.

28

29 This issue is even more apparent in "Adam Reigns in Eden", where the entire discourse setting of the

- 30 article, the take-off point for the article, situates the textual analysis of Genesis 2 in the face of
- 31 statements made with reference to the Human Genome project concerning the minimum size of the
- 32 human population necessary to account for the information in the human genome. Also later in the
- 33 article, he explicitly notes that 'the impetus of this study has been the challenge emerging from modern
- 34 science'.⁴⁴ Thus, while most of the textual work in the article makes very little reference to the question
- of Adam's biological genesis of the human race (the point of the question taken up above concerning
- 36 RPT 4.4), a dominating take-home point of the article is to make room for the conclusions of
- 37 contemporary geneticists. In fact, while there are many very compelling aspects to Mr. LeFebvre's
- treatment of Genesis 2, especially with situating it in the context of the rest of the book of Genesis, we

- 1 find the weakest parts of the textual analysis specifically surround this point. Not only is the point of
- 2 the human genome largely irrelevant for the work on Genesis 2, but it also does not particularly
- 3 strengthen the textual analysis when it does get introduced.
- 4
- 5 Concerning explicit statements on the issue of the authority of scripture vis-à-vis scientific inquiry in
- 6 Mr. LeFebvre's writings, there are a few. On p. 126 of *Liturgy of Creation*, he states "We need to turn
- 7 elsewhere [than Scripture] to explore the questions raised in the scientific quest." On p. 200 in *Liturgy*
- 8 of Creation, he draws out a historical effect in which the findings of science provide a filter for plausible
- 9 interpretations for Biblical texts, a position which seems to give scientific investigation a sort of veto
- 10 over scripture. In this context is a quote from Francis Watson on liberation of Biblical text from
- 11 captivity to natural sciences. And further, on page 208, he writes, "It is prudent to respect the
- 12 consensus of the scientific community on natural origins", and on page 219, "We don't need better
- 13 science from Genesis 1." A sort of emblematic comment on page 209 distinguishes
- 14 practical/theological purposes as being the guide of Biblical texts and in contradistinction from the
- 15 scientific features.
- 16

17 We interacted with him on this point specifically, whether scripture ever has the function of correcting

- 18 scientific doctrine, or whether they just exist in complementary spheres. In this discussion, Mr.
- 19 LeFebvre indicated that he is not intending to endorse a position that segregates Biblical and scientific
- 20 authority, and he noted many ways in which scientific pronouncements have been properly nullified
- 21 on scriptural authority in the positions of the church, and these include statements he helped craft.⁴⁵
- 22 Indeed, he consistently notes in the 12th chapter of *The Liturgy of Creation* that scientific authority is not
- parallel to Biblical authority, in that scientific authority is fallible (e.g., on p. 201 and later in more
- 24 detail on p. 209). Hence, as he advocates caution in applying Biblical authority to scientific questions,
- 25 he would be advocating more of a stance of skepticism of claims concerning natural events and models,
- regardless of the source of such claims. Similarly, on p. 209, he notes '[s]cientific institutions are
- 27 fallible. There are many reasons to critique the claims of mainstream science ...'. In addition, in your
- 28 committee's interactions with Mr. LeFebvre, he asserted his agreement with the Chicago declaration as
- 29 well as agreement with the confessional positions of the church concerning Biblical authority.

⁴⁵ In our discussion with Mr. LeFebvre on the issues of scientific authority, he requested that we consider his work found in *The Gospel and Sexual Orientation* (Pittsburgh, PA: Crown & Covenant Publications, 2012) and *Gender as Calling: The Gospel and Gender Identity* (Pittsburgh, PA: Crown & Covenant Publications, 2017). We did survey these materials as part of our work. In page 11 of *The Gospel and Sexual Orientation* we find a commendable balance of respecting the scientific community and the need for skepticism of certain scientific conclusions due to false presuppositions and political motivations within the community. It does seem the current writings under review strike a different tone on the authority of science as it relates to creation. So, it is legitimate to commend some of Mr. LeFebvre's work on this issue while raising concerns about another. It is also noteworthy that both *The Gospel and Sexual Orientation* and *Gender as Calling* treat Genesis 1 and 2 as creation-of man-narratives that recount the same creation event (see *The Gospel and Sexual Orientation*, 38-40 and *Gender as Calling*, 24-26). In particular, p38 of *The Gospel and Sexual Orientation* has this header on page 38: "1. Genesis 1:27-28, 2:20-25 – The Creation of Man". The point in *Gender as Calling* may be less clear, but page 26 does speak of Genesis 2 as a "Creation account". Mr. LeFebvre has now written against such a view in *Adam Reigns in Eden* (see discussion of this in Section 2 above).

1 2 A common approach to guiding the interaction of scripture and science is to attempt to segregate the 3 topics which are subject to scriptural and scientific authority. However, it is clear that this approach is 4 also not being advocated in Mr. LeFebvre's writings, especially as evident in his bringing up many areas 5 of concern in the science-scripture debate in The Liturgy of Creation chapter 12. However, we note that 6 Mr. LeFebvre does tend to slip into a mode that distinguishes scriptural authority as involving matters 7 of practicality (for example on p. 208 of The Liturgy of Creation where he notes "the ... right use of the 8 creation narrative for practical guidance ..."), in distinction from scientific authority as involving the 9 "actual". Whether this is intended or not, we note many of our discussions about the textual claims of 10 the book were greatly complicated by the uneasy perception that an actual set of events, which would be the target of scientific inquiry, are being assembled in a fabricated wrapper for practical purposes, 11 12 and that the actual events are far less relevant for the purposes of the text in getting people to act and 13 think in a particular way.

14

15 There are also several aspects of The Liturgy of Creation's 12th chapter which give other cause for 16 unease. The first are various somewhat extravagant claims about evolutionary theory, the most 17 commonly noted which is on p. 202, that "evolution just happens to be one of the most profound 18 scientific insights of the modern world." This statement draws much attention, as species evolution is 19 the crucial point at question in RPT 4.4. It is very unclear exactly what insight is being lauded in *The* 20 Liturgy of Creation, but later references to evolution in the paragraph seem to include more than just the observation that biological adaptation is aided by the removal of genotypes which do not fit an 21 22 environment (Darwin's original observation), but sweeps any and all temporal process explanations 23 into the term. The committee has noted that these sorts of extravagant claims for evolution are 24 endemic in the ubiquitous contemporary apologetics for materialistic naturalism. Also, a number of 25 communications make reference to the further discussion on pp. 210 and 211, in which Mr. LeFebvre 26 decries the stances of Christian communities to many areas of inquiry from psychology to climate 27 science as being due to a 'poisoning of the wells' fallacy created by controversy surrounding Genesis 1. 28 In this section, it appears that he is endorsing some sort of uncritical acceptance of mainstream 29 positions as the default expectation, and divergence from this default must be due to problems on the 30 side of the Christian community.

31

32 In fairness to Mr. LeFebvre's stated concerns about con contrarianism in Chapter 12 of The Liturgy of

33 *Creation*, we note further that maintaining healthy skepticism concerning science is not easy to do,

which is why individuals engaged in science need to constantly check each other for gullibility and bias. 34

- 35 The major issue among those opposed to the standard positions espoused by mouthpieces of the scientific establishment is not excessive skepticism, but selective skepticism. A problem with contrarians 36
- 37 concerns their willingness to believe statements contrary to popular opinion, simply because they are
- 38 contrary to popular opinion. The proper position is one that is consistent in weighing what is known
- 39 regardless of the sources, taking into account what we know about the likelihood of such knowledge

being credible, based on our understanding of the limitations to scientific inquiry and likelihood of
 biases infecting our and others beliefs.

3

4 When we consider the topics surrounding Mr. LeFebvre's writings on creation matters, it becomes

- 5 fairly easy to see why scientific inquiry is going to be limited and indirect at best. For instance,
- 6 concerning the size of the community at the time of Adam, the distance in time alone removes any
- 7 ability to probe the question directly. In addition, methods of reconstruction all assume that current
- 8 conditions or currently constructible conditions need to have applied at the time, and that no unique
- 9 events have occurred since that time, and that there are no crucial discontinuities between current and
- 10 past conditions. These obvious constraints on scientific inquiry need to be recognized.
- 11
- 12 The conclusion that this leads to is that Christians need to have the disposition of healthy skepticism
- 13 with respect to science. Indeed, an important disposition for practicing scientists to learn is just this
- 14 sort of skepticism. Thus, we find it very unwise to predicate a scriptural analysis, or even to situate a
- 15 scriptural analysis in the light of scientific pronouncement, as Mr. LeFebvre has done in his
- 16 construction of "Adam Reigns in Eden". Such a disposition is likely to stir up conflict within the
- 17 church, as has happened in this case, dragging Biblical interpretation into the same mode of thought as
- 18 scientific investigation. In addition, situating scriptural analysis in this way is not likely to aid an
- 19 accurate interpretation of the meaning of scripture. This is all the more likely in areas surrounding the
- 20 text of Genesis where many prominent members of the scientific community have very strong biases
- 21 against the philosophy and content of the Genesis narrative.
- 22
- 23 The current very unsatisfactory situation is that we believe that in Mr. LeFebvre's writings,
- 24 pronouncements by scientists are being used to introduce and support doubts concerning the Biblical
- 25 interpretation that Adam and Eve were the sole progenitors of humanity, setting up the specter of the
- 26 familiar pattern of persistent retrenchment of Biblical orthodoxy in the face of secular science found
- 27 throughout the 20th century in various churches.
- 28
- 29 To be clear, the position we believe the church should be advocating is that Christians need to
- 30 recognize the limitations of modern science, and not be swept up into the spirit of the times which sets
- 31 up scientific experts as oracles of general revelation. Further, we believe it extremely unwise to
- 32 predicate the interpretation of scripture on the pronouncements of science, and though Mr. LeFebvre
- 33 properly and eloquently decries the importing of natural science into the scriptural narrative
- 34 throughout *Liturgy of Creation*, we believe that he has done just this in his discussion of Genesis 2 in
- 35 "Adam Reigns in Eden".
- 36
- 37 IV. An Evaluation of Mr. LeFebvre's Faithfulness to his Ordination Vows
- 38
- At this point, this paper must turn specifically to Mr. LeFebvre's own questions about his adherence to his ordination yours. To assess his adherence, we will expluse yours 4, 8, and 9.
- 40 his ordination vows. To assess his adherence, we will evaluate vows 4, 8, and 9.
- 41

1 Ordination Vow 4⁴⁶

23 In many ways, the committee has already made its case concerning Mr. LeFebvre's continued

4 adherence to the system of doctrine committed to in vow 4. We have argued that an exception to RPT

5 4.4 and the corresponding positions argued by Mr. LeFebvre present extensive problems within

6 themselves. His positions have created a ripple effect of conflict with a plethora of areas within the

7 confessional standards, addressing issues ranging from creation to covenant to anthropology and

- 8 beyond.
- 9

10 This doctrinal interrelation tied to these issues has led the Reformed church to long assert that the

11 organic unity of the human race is foundational, or systemic, to the teaching of Scripture. As one

- 12 example, B.B Warfield (1851-1921) argued this:
- 13 The question of the unity of the human race ... is of indubitable theological importance ... It is
- 14 also the postulate of the entire body of the Bible's teaching of its doctrine of Sin and

15 Redemption alike: so that the whole structure of the Bible's teaching, including all that we

16 know as its doctrine of salvation, rests on it and implicates it.⁴⁷

17 Belief in RPT 4.4, then, is not an anecdotal piece of Reformed theology, the Westminster Standards,

18 or the RPCNA testimony. In other words, the belief of RPT 4.4 finds itself as part of a system of doctrine.

19 Denial of RPT 4.4 thus constitutes non-adherence to the system of doctrine.

20

21 Of course, arguments arise here as to how to define our system of doctrine. In 20-01, Mr. LeFebvre has

22 presented elements of what seems to be his working approach to issues of defining the system of

23 doctrine. For Mr. LeFebvre, the system of doctrine is best categorized as a list of doctrines noted as

24 primary, as opposed to the doctrines that would be secondary or non-systemic.⁴⁸ This "list approach" would

seem to categorize each of the individual statements or paragraphs of the testimony and confession as

26 systemic or non-systemic. Mr. LeFebvre cites Charles Hodge's work on this issue as representative of

1	such a view. ⁴⁹ Of course, as Mr. LeFebvre laments, the RPCNA has not delineated such a list, and so,
2	in this paradigm, the list is to be determined or guessed at by each individual office-bearer.
3	
4	Our committee offers no objection at this point to identifying some statements as systemic and others
5	as non-systemic. Nonetheless, in this approach, two realities must be maintained.
6	
7	First, one must recognize that broader systemic doctrines would come with many necessary particulars.
8	In the cited work of Charles Hodge, Hodge cites summaries of heads of doctrines, largely by working
9	through chapter summaries of the Westminster Confession of Faith. Immediately, this seems different
10	from Mr. LeFebvre's apparent proposed approach of listing out individual testimonial statements as
11	systemic or non-systemic.
12	
13	Within broader doctrinal expressions, likes the ones Hodge articulates, some particular doctrinal
14	points will be necessary to understand the broader doctrine. As one example of this, consider Hodge's
15	own Systematic Theology, in which his entire volume on anthropology begins with an extensive argument
16	against Darwinian thinking and an argument for the necessity of the unity of the human race for a
17	proper anthropology. ⁵⁰ There, the particulars prove necessary for the whole.
18	
19	Second, one must recognize the interrelation of doctrines with each other within the broader system.
20	The tenor of Mr. LeFebvre's presentation seems to advocate an atomistic approach to the system of
21	doctrine. In an atomistic view, each statement is evaluated "on its own" for its systemic quality. With
22	such a view, tracing the connections of the doctrine to the remainder of the standards would constitute
23	a slippery-slope fallacy. Presumably, in this case as an example, the argument would be that one could
24	simply not affirm RPT 4.4 while holding all the systemic features of doctrine to which RPT 4.4 relates.
25	
26	And yet such a view moves against the very nature of a system. The language of system inherently speaks
27	to the interrelation of ideas, concepts, or processes. The weight of a doctrine is shown, not by the bare
28	statement of the doctrine, but by the observation of its inherent relation to the unified whole of the
29	church's confession. Some doctrines, it may be discovered, do not speak too significantly to the
30	broader whole. Others, as we find with RPT 4.4, are themselves as one part of an interlocking broader
31	whole involving many related points. Thus, we argue that RPT 4.4 is systemic and that denial of such
32	lands one outside of the system of doctrine.
33	
34	At this point Mr. LeFebvre's concern arises that assertions about systemic statements like this just
35	appear at the whim of presbytery. ⁵¹ It might even be argued that it is unfair at this point to speak to

1 RPT 4.4 as systemic – and to hold Mr. LeFebvre accountable to that – when that assertion has not 2 previously been stated in a formal sense by the presbytery. 3 4 And yet, in this case, such a disagreement reveals an approach to exceptions to doctrine that is at 5 variance with the process outlined within the denomination. It was not at a whim that the 2003 synod 6 adopted this guideline: 7 8 That Synod remind all officers of the church that if they find themselves out of accord with the 9 Confessional Standards of the church, their beliefs and commitments having changed, it is their duty to declare their scruples and differences with the Westminster Confession of Faith, 10 the Larger and Shorter Catechisms, or the Testimony of the Reformed Presbyterian Church to 11 their Presbytery if a Teaching Elder, or to their Session if a Ruling Elder or Deacon.⁵² 12 13 14 The guideline adopted here presented the route of announcing differences with the standards of the 15 RPCNA. And while one may disagree with this formation of the process, as the clear recommendation 16 of the synod itself, it is the standard that must be followed. 17 18 And ultimately, this process has now taken place. The exception has been declared to the presbytery, 19 and the reviewing committee has now presented an argument that RPT 4.4 is indeed systemic. Insofar 20 as the presbytery aligns to this viewpoint, Mr. LeFebvre can rightly be seen to no longer be within the 21 bounds of ordination vow 4. 22 23 Ordination Vow 8⁵³ 24 In vow 8, ministers agree to do that which promotes the "purity, peace, unity and progress of the 25 26 church." Embedded in this vow would be a commitment to pursuing the truth, and our committee is 27 confident that Mr. LeFebvre has attempted to do that with his writings. 28 29 However, the approach Mr. LeFebvre has taken cannot be regarded as a faithful pursuit of the peace 30 and unity of the church. In the opening page of the preface to his book, Mr. LeFebvre affirms that "the 31 meaning of the creation week continues to be one of the most controversial issues in the church 32 today"⁵⁴. With this statement, the committee completely agrees. As has been noted, in recent years, as

33 one example, the OPC has been embroiled in lengthy, extensive debates over issues quite similar to

these.⁵⁵ Any informed observer would know that the publication of Mr. LeFebvre's materials in the
public square would inevitably create significant controversy.

- 3
- 4 Of course, controversy itself is not necessarily to be avoided. The promotion of progress in the church
- 5 will at times create controversy. But the realities surrounding a topic such as creation and the
- 6 immediate creation of Adam and the processes already given to the teaching elders of the church⁵⁶ -
- 7 cannot be avoided when assessing adherence to vow 8 in these writings. This reality is even more the
- 8 case when portions of the writings speak against the standards of the church.
- 9
- 10 With this in mind, a critical assessment is in order when evaluating Mr. LeFebvre's publishing
- 11 approach. There are processes laid out, such as the communication of scruples, the seeking of counsel
- 12 in the church courts, or even the seeking of change of our standards through the church courts, that
- 13 Mr. LeFebvre did not follow that would have enabled a greater pursuit of peace and unity. These
- 14 processes, combined with Biblical wisdom should also have commended to Mr. LeFebvre a desire to
- 15 deal with these matters within the courts of the church.
- 16
- 17 The courts serve as a means of protection for ordained officers and churches alike. For officers, it
- 18 provides them a forum to engage their views and ask questions without moving headlong into error
- 19 without accountability. For churches and their members, it protects them from teaching contrary to
- 20 the church and Scripture. The process also protects the peace and unity of the local church. It enables
- 21 them to trust the public ministry of the church's ministers as in accordance with the constitution
- 22 which they have affirmed as being based upon the Scriptures.⁵⁷
- 23
- 24 It is clear, though, that Mr. LeFebvre did not pursue this route of protection and caution. Much of the
- ensuing controversy, critique, and "cloud of suspicion"⁵⁸ can be pointed directly back to this
- 26 publication decision and approach of Mr. LeFebvre. While it is possible for onlookers to respond to
- 27 Mr. LeFebvre's writings in error, the existence of these tensions themselves is not the fault of the
- 28 onlookers. They are the natural result of decisions from Mr. LeFebvre that have moved against the
- 29 peace and unity of the church.
- 30
- 31 Thus, the committee believes Mr. LeFebvre has not consistently pursued the peace and unity of the
- 32 church in accord with vow 8.
- 33

1 Ordination Vow 9⁵⁹

2 3 Finally, Mr. LeFebvre's own work in 20-01 explores his conformity to yow 9, and so the discussion of 4 this vow must be taken up. It has already been argued in this paper that Mr. LeFebvre has written in 5 ways contrary to the standards of the church. That in itself creates an argument that he has engaged in 6 divisive discourses to the doctrine of the church. 7 Here we must note the language of "divisive discourses" seems most naturally to apply to discourses 8 9 that objectively divide from the church's doctrine. Vow 9 refers to divisiveness to "doctrine and order" 10 and not to divisiveness in terms of an angry spirit or a desire to be antagonistic. The most warm and gentle teaching could be found divisive if it divides from the doctrine and order of the church.⁶⁰ 11 12 13 In 20-01, Mr. LeFebvre presents two threads of argumentation as to his not having engaged in divisive 14 discourses in terms of doctrine.⁶¹ We will consider each of these here: 15 16 1. Mr. LeFebvre points to his not having taught these truths in the life of the congregation. 17 18 We believe that Mr. LeFebvre has not publicly preached or taught against RPT 4.4 or on all his 19 views on the creation week within the life of the church. That said, when evaluating his 20 writings, it seems disingenuous to assert that his teachings have not come to the local church, 21 whether his congregation or others. His writings on creation and Adam appear on BioLogos, 22 which "invites the church and the world to see the harmony between science and biblical faith as we present an evolutionary understanding of God's creation."⁶² In Liturgy of Creation, he 23

explicitly speaks to his motivation for writing being out of his role as a pastor, particularly in 1 view of his calling to Christ Church Reformed Presbyterian.⁶³ The goal of the book, then, is to 2 3 write pastorally, with an audience of churches and members of congregations. Further, Adam 4 *Reigns in Eden* is easily accessible online to anyone in the church. In short, the aim and 5 audience of Mr. LeFebvre's writings have indeed included those within the church, whether 6 the congregation he pastors or the church at large. 7 8 And finally, the output of his writings is clear. They have reached the local church. They are 9 being purchased and read by members of congregations who are now being forced to interact 10 with these teachings. 11 12 These teachings may not have appeared in Christ Church Reformed Presbyterian on Sunday 13 morning. But they are readily available to the members of his congregation, the entire RPCNA, 14 and the church at large every day of the week. And that availability comes, not from an 15 accidental discovery of the writings by congregants, but by the intentional efforts of Mr. 16 LeFebvre in his writings and those of the publishing agencies through which he publishes. 17 18 2. Mr. LeFebvre argues that this writing proceeds from his scholarly vocation in contrast to his pastoral 19 vocation. 20 21 The committee acknowledges this point at one level. Mr. LeFebvre has a capacity for scholarly 22 pursuits that may not always appear in the immediate life of his local congregation. That being 23 said, this distinction between pastoral and scholarly vocation seems arbitrary and not 24 consistent with the natural meaning of our Presbyterian structure. The RPCNA has two 25 ordained offices: elder and deacon. In the vows a teaching elder takes, "the earnest study of the Word"⁶⁴ falls under the work of the minister. Earnest study of the Word is not seen as of a 26 27 different vocation than pastoral calling, but falls within the calling. Every faithful minister will 28 engage in various levels of scholarly pursuit, of which various portions of that will appear in the 29 teaching of the local church or the church at large. 30 31 Pursuing scholarly work is a fine effort for a pastor. Ministers are permitted to ask questions 32 about issues found within our standards. They are permitted to develop and promote doctrinal 33 thinking in areas not contrary to our confession. There are even routes for advocating changes 34 to the standards within the courts of our church. 35 36 And yet, when it comes to public writings, whether of a scholarly nature or not, that pursuit 37 must be done within a Presbyterian context and manner. In the case of vow 9, that means not

2		itself in a scholarly field and not immediately within the pulpit.
3		
4 5	Thus, we conclude that within Mr. LeFebvre's writings, there are evident teachings that run against the vow made in ordination vow #9.

7	V. Sun	nmary Answers to the Questions Posed in 20-01
8		
9	The committee seeks to make clear it's answers to the questions posed in 20-01. Therefore, before our	
10	recom	nendations, we will offer our concise answer to each question posed in 20-01:
11		
12	1.	Does this court find that my understanding of RPT 4.3, WCF 4.1, and the titles of Adam in, for
13		example, WCF 6.3, are consistent with my ordination vows?
14		
15		In RPT 4.3 and WCF 6.3 and many other places, the committee finds discord between Mr.
16		LeFebvre's positions and many areas in the standards. Thus, we do not find Mr. LeFebvre's
17		views of these areas are being held consistently with the ordination vows.
18		
19	2.	Does this court find that my exception to RPT 4.4 is being held consistently with my ordination vows?
20		
21		As reflected in the arguments found in sections 2 and 4 of this paper, the committee does not
22		find the exception to RPT 4.4 is being held consistently with the ordination vows.
23		
24	3.	If this court regards my understanding of any points noted under question 1 (i.e., RPT 4.3; WCF 4.1;
25		6.3, etc.) to be inconsistent with the church's standards, are those exceptions nonsystemic and am I
26		holding them consistently with my ordination vows?
27		
28		The committee believes that there is an inherent systemic relation between the issues noted in
29		this question. The committee believes that the positions held, on the whole, have moved
30 21		against the system of doctrine as expressed in the confession and testimony.
31		
32		Additionally, the committee believes that the manner in which these positions have been held
33 34		and taught (see section 4 above) is not consistent with the ordination vows.
35	We con	no to these conclusions with heaviness of heart. For many years, we have gratefully served
36	We come to these conclusions with heaviness of heart. For many years, we have gratefully served	
37	alongside Mr. LeFebvre in the life of the church and presbytery. In many areas, his preaching, teaching, writing, and service have blessed the church and the committee personally. We would wish for any	
38	other conclusion than to articulate that Mr. LeFebvre has now fallen outside the vows of ordination.	
39	But in love for Christ, His church, and for Mr. LeFebvre as well, we find it necessary to observe the	
40	serious errors in the teachings in review. We come to these conclusions with a longing for the peace of	

1 the church and the blessing of the gospel for Mr. LeFebvre, Christ Church RP, and all of Jesus'

1. That an exception to RPT 4.4 be found out of accord with the system of doctrine set forth in the Westminster Confession of Faith, the Larger and Shorter Catechisms, and the Testimony of the Reformed Presbyterian Church.

- That the presbytery counsel Mr. LeFebvre to repent within 90 days of September 11, 2020
 of the position that this Court has recognized as against the system of doctrine.
- That Mr. LeFebvre be admonished for failing in his pursuit of the "purity, peace, unity and progress of the church" (vow 8) in the process he has followed in his teachings and writings on creation and Adam.

- 16 5. That presbytery form a judicial committee to determine a future course of action,

 the presbytery institute proceedings against Mr. LeFebvre by appointing a special
 prosecutor to pursue the case & bring charge(s) against Mr. LeFebvre pursuant to the Bool
- prosecutor to pursue the case & bring charge(s) against Mr. LeFebvre pursuant to the Book
 of Discipline (2.1.3, E-9 and 2.2.1, E-10). This committee would also be tasked with
- 21 evaluating Mr. LeFebvre's response to the admonishment concerning vows 8 and 9.
- 22 6. That during the process of evaluation and judicial analysis, Mr. LeFebvre be directed not to
- 23 publish written material or speak in public forum (lecture, podcast, etc.) on the issues
- 24 directly in view of this discussion, namely the origin of Adam and evolutionary approaches25 to origins.
- 26 7. That the LeFebvre Writings Study Committee be dismissed.

4 5 6 7	Listed below are questions for clarification and discussion for Michael LeFebvre from the <i>LeFebvre</i> <i>Writings Study Committee</i> . These questions come as a particular attempt to fulfill part 4 of our mandate from Presbytery: To interact with Dr. LeFebvre for the purpose of understanding and clarification of the relevant points raised in the writings being evaluated.
8 9	These are written with the intent of guiding an in-person discussion with Michael LeFebvre about each of these questions.
10 11	Questions are broken down below by topic. Our questions engage the following topics: Scripture, Creation and Anthropology, and the Ordination Queries/System of Doctrine.
12	On the Doctrine of Scripture
13 14 15 16 17	1. In <i>Liturgy of Creation</i> , your introduction speaks to intentional alterations of timing of the crucifixion narrative by the apostle John. This reading of John also serves as a sampling of your exegetical approach to many issues in dating within the Old Testament. This may seem to suggest that you are teaching that there are contradictions in the details of Scripture or that the narratives of Scripture do not harmonize.
18 19 20	Could you clarify your view on the harmonization of Scripture and the nature of contradictions in the details of Scripture? How does your view align with RPT 1.13 and WCF 1.5 (on the "consent of all the parts")?
21 22 23 24	2. In reference to RPT 1.5: In your thinking and practice, how do we differentiate limitations to the text with respect to viewpoint and idiom, as opposed to violations of the concept of inerrancy? While the works present parts of passages as being encoded in the idiom of the day, it might be equally valid to present these passages as simply being wrong.
 25 26 27 28 29 30 31 32 	3. John 1:45, John 5:46 and Romans 10:5 (and other verses by inference, such as Mark 12:26; Luke 16:29, 31; Luke 20:37; Luke 24:27; Acts 15:21; 2 Corinthians 3:15) say that Moses wrote the books attributed to him as "the Law of Moses". Recognizing that Moses almost certainly didn't write Deuteronomy chapter 34 about his own death and burial a question still remains: what portions were written by Moses and how can we know? Or perhaps, if the first few chapters of Genesis were not written by Moses, but by a later author while the Israelites were in the promised land, how do we know which parts were written by Moses?

1 Perhaps clarify your comments here in references in your book to "the original compiler of the

- 2 Pentateuch" (p82) and the "original compiler" (p119).
- 3 4. On page 126 of *Liturgy of Creation*, you write, "We need to turn elsewhere [than Scripture] to explore
- 4 the questions raised in the scientific quest." On page 201 you write, "The Bible is not given ... 'for
- 5 training in science." On page 208, you argue for the removal of the creation narrative from
- 6 "naturalistic inquiry."

7 Can you clarify how you are defining science/the scientific quest, and naturalistic inquiry? In what way

- 8 does Scripture speak to the scientific quest and inquiry? What makes science conclusive, and can we
- 9 ever adopt interpretations of an issue on which scientific consensus speaks otherwise? Perhaps engage
- 10 with this in view of RPT 1.2 and particularly, RPT 1.3 on the way general revelation is only rightly
- 11 understood in view of God's Word.

On Creation and Anthropology

13 1. You say that you uphold RPT 4.3 because you interpret it to be only rejecting a specific form of

14 evolution ("'which assumes that chance happenings are an explanation' for all matter and life") and

- 15 you support that by also saying, "we actually affirm that some processes of evolutionary change do
- 16 occur 'within [the] genetic limitations provided [by God] at creation'" (communication 20-01). The
- 17 Testimony does not refer to those changes as "evolution" and yet you do (by referring to them as
- 18 "evolutionary processes"). The Testimony's statement seems to say that change within a species (or even
- 19 a family) is what the Bible refers to as "according to its kind". Is your statement analogous to the
- 20 position of many evolutionists that conflate species-to-species change ("macroevolution") with change
- 21 within a species ("microevolution")?

22 2. Your paper asserts that "Adam may also have been the first human being and progenitor of the whole human

- 23 race." Simultaneously, you note that the creation narrative "presupposes the presence of other populations"
- 24 and that the "author's worldview includes other populations already present". These assertions seem to directly
- 25 contradict one another. How do you reconcile these ideas (Adam as potentially being the first human
- 26 being and the assumption of other populations outside of Adam)?
- 27 3. In Adam Reigns in Eden, you argue for Genesis 1 and 2 being separate narratives. See p44-45: "The
- origin of all humanity is the burden of a passage in the previous chapter: Genesis 1:26-27. That text
- 29 reports that God created humankind in the categories of "male and female" by his command. But the
- 30 Eden narrative tells a different story." You also acknowledge that your writings produce this question
- 31 (p55): "Were populations in "the land of wandering" Homo sapiens, or was the "breath of life" given to Adam a
- 32 distinct mark of the first Homo sapiens within a broader, interbreeding hominid population?"
- 33

- 1 What are we to make of these potential *homo sapiens* populations? Were they image-bearers of God with
- 2 the breath of life, as referenced in Genesis 2:7? How does the existence of these other hominids
- 3 comport with WCF 4.2 on the timing of the creation of man in His image after creating all other
- 4 creatures?
- 5 4. In Adam Reigns in Eden, you suggest that Adam may not literally have been formed from the dust of
- 6 the ground and that perhaps instead he descended from other hominids. How do you see your
- 7 statements aligning with WLC 17? "After God had made all other creatures, he created man, male and
- 8 female; formed the body of the man of the dust of the ground, and the woman of the rib of the man;
- 9 endued them with living, reasonable, and immortal souls; made them after his own image."
- 10 5. In RPT introduction, paragraph 3, we assert, "When Adam broke the covenant by disobedience
- 11 death came upon him and all mankind since they were included in the covenant." Why would the rest
- 12 of mankind be cursed if they were not actually descended from Adam? How does your view align with
- 13 this paragraph?
- 14 6. RPT Intro:3 says, "When Adam broke the covenant by disobedience death came upon him and all
- 15 mankind since they were included in the covenant. But God delayed the final sentence of death..." We
- agree that the death threatened by God, "you shall surely die" in Genesis 2:17 includes spiritual death,
- 17 but the Testimony clearly means that it includes physical death as well (since spiritual death was
- 18 immediate, but it was physical death that was delayed). The clear implication then of the Testimony is
- 19 that physical death was part of the penalty of that first sin by Adam and so for there to have been
- 20 physical death of mankind prior to that is unscriptural. Was there death among mankind prior to that
- 21 point?
- 22 7. Is human death a good thing or bad? If bad, and it existed for many years, perhaps thousands or
- 23 millions of years, how do you understand Genesis 1:31 in which God declares all that he had made
- ²⁴ "very good"? If good, then how do you understand 1 Corinthians 15:26 which says the "the last enemy
- 25 that will be destroyed is death"?
- 26 8. In Adam Reigns in Eden (page 1) you introduce the concept of as many as 10,000 pairs of founders of
- humankind, and you say, "... the human race embodies remarkable genetic diversity that, according to
- the operations of genetics, cannot be explained by a single set of parents." How is that reconciled with
- 29 the account of the flood where the Bible declares that all human life other than those on the ark was
- 30 destroyed, that only 8 people were on the ark (Genesis 7:7, 1 Peter 3:20 and 2 Peter 2:5) and goes on
- 31 to tell us that all modern humans must be descended from the three pairs of humans (Noah's sons and
- 32 their wives) that were on the ark?
- 33 9. In communication 20-01, you address questions of the relationship of your writings to the doctrine
- of original sin. You address WCF 6.3, but you do not speak to WLC 26, which seems to more clearly
- 35 discuss the genetic connection of mankind to our first parents. WLC reads: "Original sin is conveyed
- 36 from our first parents unto their posterity by natural generation, so as all that proceed from them in

that way are conceived and born in sin." Could you speak to how your position relates to the statementof WLC 26?

3

On the Ordination Queries and the System of Doctrine

1. In 20-01, you assert that RPT 4.4 has never been declared to be part of the system of doctrine. But,
as you've noted, declaring paragraphs as part of the system of doctrine has not been part of the church's
practice. So, the same question could be flipped: on what basis do you determine it not to be part of

- 7 the system of doctrine?
- 8 2. In communication 20-01 (page 4), you write, "I do not believe my work contradicts the church's
- 9 settled doctrine." And yet, in the same communication, you note your exception to RPT 4.4. Do you
- 10 not believe RPT 4.4 to be the settled doctrine of the RPCNA? Or are you using "church's settled
- 11 doctrine" in a different sense?

12 3. Could you relate to us the process by which you interacted with other presbyters prior to publishing

13 the three works in question? When did you inform your session of the publications, and how much of

14 the documents did they review prior to submission for publication? Similarly, how and when did you

15 request input concerning these works concerning their controversial nature from elders across the

16 presbytery, and how did you determine who to consult? What counsel did you receive from them along

17 the way?

18 4. Per Ordination vow 8, how do you see your approach functioning to "promote the purity, peace,

19 unity and progress of the church"? How does publishing multiple materials on what you acknowledge

20 "continues to be one of the most controversial issues in the church today" (Lit. of Creation, xii),

21 without submitting them to the presbytery for review, comport with adherence to query #9?

22 5. You identify yourself as an Adjunct Professor of Old Testament at RPTS on your book cover. Did

23 you submit a copy of your manuscript and journal to the Seminary Faculty/Administration for review

- 24 and counsel before publishing it? What counsel did you receive?
- 6. On 20-01: in your last paragraph, you make a distinction between your pastoral vocation (i.e. your
- teaching within the church) and your scholarly vocation. In terms of your ordination vows, can you
- 27 clarify how you ascertain the existence of such a distinction? Since your materials are easily accessible
- 28 and widely read within the local church/presbytery, it is clear that pursuing scholarly work has and will
- 29 have profound pastoral implications.

3 Fathers and Brothers of the Great Lakes-Gulf Presbytery,

4

5 We write with appreciation for the work of the LeFebvre Writings Study Committee. These 6 brothers have agreed with Mr. LeFebvre that he is out of accord with Reformed Presbyterian 7 Testimony 4.4. The committee gave helpful analysis to demonstrate this reality, and we are 8 thankful for their commitment to remain within their remit.

9

However, we are concerned that their recommendations do not sufficiently consider the whole scope of presbytery's responsibility before hastily moving to serious action that will be essentially irreversible and may produce unintended consequences. We also believe this course will set a poor precedent and could reflect poorly on the church. We understand how a committee can conclude after finding a man out of accord at a significant doctrinal point that the only options are to vote "up or down." But, in this case, we believe there is more work remaining if we are to be found faithful and true in our calling.

17

18 Motion to Substitute Planned

19

We plan to introduce a motion to substitute and then take up the recommendation below as an alternative way forward. We believe a somewhat more measured approach will result in greater progress, peace, and prosperity in Christ's kingdom. It is important to note that Mr. LeFebvre has had no hand in formulating this idea and is seeing this proposal for the first time along with

the rest of presbytery.

25

26 We have several concerns regarding the committee's recommendations, but our greatest 27 concern is this: It seems to us that significantly absent in the whole approach is any attempt to win Mr. LeFebvre to our position on RPT 4.4. In fulfilling their remit, which was to understand 28 29 Mr. Lefebvre's teaching, the committee members asked questions of him in writing, met with 30 him once to ask questions, and then met a final time to inform him of their direction. Now, they 31 recommend that he simply be given 90 days to repent. But their work was essentially focused on 32 his positions relative to our standards. They did not reason with him personally on the content 33 of his work from Scriptures. We understand that this was not their remit, but it is our remit as a 34 presbytery to do everything we can to win our brother (Matthew 18:15ff). To take judicial action 35 without a deliberate and strategic plan to reason with Mr. LeFebvre would lack the pastoral care 36 we owe our brother.

37

38 Mr. LeFebvre's History

39

In crafting a plan to win Mr. LeFebvre, we must consider his past performance. He has a track record of seeking the peace and unity of the church in the courts; arguably, his record may outshine every other member of this court in specific application. Consider his efforts serving on the committee to work with Mr. Ray Lanning, and his tedious work on papers regarding difficult matters such as sexual orientation, gender identity, and the manner of collecting tithes and 1 offerings, just to name a few. All of these activities in the courts led to greater peace in the 2 church.

3

4 In the case of Mr. Lanning, Mr. LeFebvre led the way in laboring with the committee through long 5 hours of many meetings seeking to understand Mr. Lanning's views. He wanted to win Mr. 6 Lanning, and the end result was Mr. Lanning's agreement with the denomination. Our presbytery 7 has engaged in no similar, formal efforts to win our brother now. Our energies have been primarily, if not entirely spent understanding whether he is out of accord or not with our 8 9 confessional documents. We are called to reflect the character of our God, as a presbytery. Our Savior warns us and promises, "Judge not, and you will not be judged; condemn not, and you will 10 not be condemned; forgive, and you will be forgiven; give, and it will be given to you. Good 11 12 measure, pressed down, shaken together, running over, will be put into your lap. For with the 13 measure you use it will be measured back to you" (Luke 6:37-38). If Mr. LeFebvre has been 14 exemplary in judging and measuring generously and faithfully in cases like that of Mr. Lanning, 15 then it would be a great blight on the church if it did not return the favor. Let us measure Mr. 16 LeFebvre with the same patient generosity he has measured others before our very eyes, making 17 every effort to win this brother. This process will involve discussing and reasoning in personal, 18 brotherly, and intellectual ways over the content of his writings and conclusions. It will also take 19 time.

20

21 Jesus famously tells the parable of the barren fig tree: "A man had a fig tree planted in his 22 vineyard, and he came seeking fruit on it and found none. And he said to the vinedresser, "Look, 23 for three years now I have come seeking fruit on this fig tree, and I find none. Cut it down. Why 24 should it use up the ground?" And he answered him, "Sir, let it alone this year also, until I dig around it and put on manure. Then if it should bear fruit next year, well and good; but if not, you 25 can cut it down"" (Luke 13:6-9). If Jesus taught to give one year to a fruitless fig tree, how much 26 27 more are we responsible to give time and attention to a brother who has borne so much fruit in 28 our court in the past. Demanding repentance in a mere ninety days without any counsel and 29 without engaging the substance of his writing with him seems to lack charity.

30

31 We also believe that Mr. LeFebvre is worthy of being given more time and attention. In the past, 32 he has always operated in good faith. He even sought clarity from presbytery on multiple occasions regarding how to understand the meaning and application of "system of doctrine" and 33 how Ordination Vow 9 relates in cases of disagreement. The report of the LeFebvre Writings 34 35 Committee also notes this in footnote 60. Although he requested clarification from us, the 36 presbytery declined to answer his questions. Perhaps mistakes have been made by him and/or 37 by the presbytery, but Mr. LeFebvre has been quite straightforward in his labor. He has acted in good faith, and we believe the recommendations 3 & 4 are premature. He has proven eager to 38 maintain the unity of the Spirit in the bond of peace (Ephesians 4:3) and we should believe that 39 he will in the time in which we would work with him. 40

41

42 Some may object that Mr. LeFebvre's exception is too serious and too dangerous to the church.

43 No doubt, Mr. LeFebvre's disagreement with the RP Testimony is significant, and the implications

44 which have not all been explored have varying levels of severity. However, it is also helpful to

note the limits of his disagreement with RPT 4.4. For instance, he does not assert that Adam had 1

2 progenitors, he is stating his belief that the Scripture does not address the issue one way or

- 3 another. Yes, there are serious possible implications, but his objection is not of such a nature that
- 4 should require such immediate action (90 days) without presbytery reasoning with him. Further,
- 5 we would not be approving his exception at this time in any way; we would be noting it and
- 6 declaring our affirmation of RPT 4.4 and our desire to win our brother back to it.
- 7

8 Further, we have the benefit of knowing that Mr. LeFebvre has a good reputation in his teaching 9 and preaching ministry at a local level without stirring dissension; we believe he can continue to 10 serve profitably as we labor with him.

11

12 Winning Our Brother - A Fresh Ecclesiastically Oriented Approach

13

14 We also think that because of Mr. LeFebvre's faithful relationship with us for many years, that 15 his case would be a good one in which to attempt a fresh ecclesiastical approach to overseeing 16 doctrinal discussions as we seek to win our brother. To win him, we will need to leverage the best 17 responses to his work which we expect may come from sources beyond our own presbytery and 18 perhaps beyond our denomination. And yet, we would oversee this work and potentially model 19 a better way forward for robust theological discussion to be had under the oversight of the 20 courts. We must guard the sound doctrine handed to us, and we must do it well (2 Timothy 1:12). 21 The creation debate at hand will go forward here or elsewhere. If we believe in a strong doctrine 22 of the church, we should be more eager to see the debate unfold, in a certain way, under our 23 auspices to the glory of God rather than in a parachurch environment.

24

25 The committee urges that Mr. LeFebvre's thoughts should have been brought to the courts of 26 the church (p. 28). In spite of the circumstances that have led us to this point, it is certainly worth 27 noting that these ideas are now before the court. The court could, of course, decline to consider them, or it could take this opportunity to lead the church forward in thinking clearly about these 28 29 topics. Since we really are obligated to seek to win our brother and will need to do some work 30 along these lines anyway, why not now take up more of the substance of his work and related 31 topics? For the work to be done well, there will need to be time for give and take in writing among 32 the best scholars we can engage. But, the wider church will see the strength of the church courts in such debate by allowing it to proceed with appropriate guardrails. The fruits of this labor, as 33 we trust the Lord by his word and Spirit could profit the church in far better ways than by farming 34 35 the work of heavy theological dialogue to parachurch ministries.

36

37 It can be argued that most doctrine through history, while usually resolved in the courts of the church, has unfolded in debates that occurred outside the courts. Today's era of immediate 38 nature of communication and the ubiquitous reach of digital documents is also changing the 39 playing field. In prior generations, theological debate could simmer among universities in the 40 code of the Latin language without disrupting lay members. Only a half-century ago, theologians 41 42 and churchmen could much more peaceably consider theological development without 43 immediately lighting the world on fire because Twitter still ran on the telegraph. 44

We want to encourage theological exploration in our circles that would foster freedom for the 1 2 likes of Augustine, Anselm, Luther, or Calvin in the RPCNA. And, we want a model that will protect 3 the church from heresy by testing all things well. We will need a model that will oversee robust 4 theological interaction that bakes slowly. We need a place where give and take is permitted, but 5 monitored well. We need a place where questions may be raised and not fully answered or that 6 are raised and leave fresh questions unanswered immediately, but not irresponsibly. 7 8 Our presbytery seems well united in agreeing with the position of RPT 4.4. We are not in danger 9 of doctrinal drift on this issue, and are, thus, in a strong position to allow time to win our brother. 10 To act hastily will actually give the appearance of undue fear, when rather we should act deliberately with confidence believing the power of our risen Savior, his word, and the Spirit. 11 12 13 Has the Lord given us a unique opportunity with a man who has shown himself trustworthy in so 14 many ways to attempt a new endeavor as a presbytery in overseeing theological discussion? Is 15 there an opportunity to clearly state to the church our concerns, note that he is out of accord, 16 but that we find him to be serious in his endeavor and willing to engage in robust dialogue? An 17 opportunity to show the watching world that we are serious about being theologically zealous 18 and with a deep care for a man and his positions in such a way that the purity of the church is 19 guarded as best as possible at every turn? We think perhaps so. The work of the LeFebvre 20 Writings Committee is certainly already a significant contribution to such study, but we believe 21 more work is needed and would benefit everyone greatly. Let us labor for truth, so that the

- 22 church is strengthened and our brother won.
- 23

24 Working as Peacefully as Possible Within the RPCNA

25

26 Before moving to our recommendation, we would simply make another observation about the 27 wider church. The wider church, especially, but not limited to, the RPCNA, is interested in our proceedings. We may feel a need to act decisively against one who takes exception to RPT 4.4 28 29 and has published contrary to it. But, for the peace and unity of the church, as well as to develop 30 a growing consensus on appropriate boundaries of theological exploration, it may be wisest to 31 take the matter more slowly to be sure we seek God's word and the counsel of many brothers 32 since the implications will be wide ranging. Certainly more time would allow for further discussion of proper procedure to be sure that whatever action is needed ultimately, everything 33 34 is done decently and in order.

35

We pray the Lord would use the model we now propose to win Mr. LeFebvre through healthy,
robust theological development in a sensitive area of theology under the oversight of the church.
We trust that the Lord will give the greatest aid to the church widely by summoning the best
arguments possible for true and faithful positions regarding creation.

- We acknowledge that Mr. LeFebvre is out of accord with RPT 4.4.

5 We affirm our confidence in Mr. LeFebvre's pastoral ministry as we give more time to seek 6 diligently to win our brother and to evaluate his progress.

7

8 We seek to win Mr. LeFebvre to the RPCNA's position by appointing a committee of three men 9 to be named by the moderator to work with Mr. LeFebvre over the next three years.

10

The committee will seek input from qualified parties from within and without the RPCNA to engage with Mr. LeFebvre's writings. The committee will actively seek contributions from those who support the RPT 4.4 position, but may also receive submissions from those whose opinions differ. Helpful submissions will be made available to RPCNA elders and contributors. This would

15 allow for robust give and take among contributors as questions are raised.

16

After three years, the committee will lead presbytery in evaluating what the Lord has done and recommend the best course of action for all of the parties.
