I write to resign my position as pastor of Terre Haute Reformed Presbyterian Church. I regret this decision, but realize now that by accepting the call some five years ago, I was offending my wife and children, and now I feel unable to continue serving here. I know that this will be a significant adjustment in the life of the congregation and I am sorry for this likely setback in ministry.

I don't mean to make excuses for my failures, but I never thought that a majority of the congregation would need special ministry beyond sitting under the preaching of the Word. It seems clear that I didn't know what I was getting myself into, and I have clearly been unable to keep up with the need for ministry and have dealt with my stress in inappropriate ways.

I also intend to contact presbytery to find out how to resign my ordination, hopefully without charges and a trial. I hope to go away peacefully with as little scandal as possible.

Finally, I am hoping that you could give me three months of severance pay, so that I have some time to sell the house and find a next step for me. Mary is gone and I will need some time, with some financial support, to figure out what to do next.

Josh and Russell, you both have been great elders. I thank you for your ministry and your support. Many blessings in Christ to you and Terre Haute RPC.

The shepherding committee met last night to discuss a path forward in shepherding Steve and Mary Rhoda, as well as the other members of the Terre Haute congregation.

Given the circumstances, including Pastor Rhoda's resignation, the committee supports the request from the Terre Haute session that the AIC dissolve the pastoral relationship between Pastor Rhoda and the congregation, declare the pulpit vacant, and provide the Terre Haute congregation with an interim moderator.

We are also mindful of how these decisions would be communicated to Steve and Mary. With this in mind, Pastor Hanson is scheduled to meet with Pastor Rhoda today to provide shepherding, counsel, and encouragement as he navigates these challenges. Additionally, Mary Rhoda's elders, Josh Reshey and Russell Lodge, are planning to meet with her this week with similar goals.

The committee would like to support and care for the physical and spiritual well-being of Steve and Mary. Josh has already contacted the Benefits Board to explore options for severance pay and the counseling grant they offer. He is also planning to meet with Russell and the Terre Haute deacons to discuss the possibility of the church providing additional financial assistance for them if needed.

We are also recommending that Steve and Mary pursue counseling, both individually and as a couple. Resources for finding certified ACBC or CCEF counselors in their area have already been shared with them. For Pastor Rhoda, we believe an inpatient or outpatient alcohol treatment program, in addition to personal counseling, could be highly beneficial. We would also like to establish a means of accountability for Steve, such as regularly scheduled check-ins with his elders or a member of the shepherding committee.

We hope this information will be helpful to the AIC as it deliberates. Please join us in praying for Steve and Mary Rhoda and for the Terre Haute congregation as we seek God's will for their recovery and reconciliation.

Dear Fik and Bob,

It's with a heavy heart that I write this letter. You brothers are dear to me as fellow elders in the ministry at ERPC. I confess that for a long time now, I have been battling ministry fatigue or burnout. I have struggled to do the work of preparations and have sunk into despair, but the Lord has graciously enabled me to carry on each Lord's Day. We have also had many ministry challenges over the last few years on the Synod and Presbytery levels, as well as locally with a number of families and officers leaving for various reasons. The present shepherding matter has brought me to the realization that I'm not able to continue. I am not able to provide effective ministry for the congregation which I have grown to love very much in the Lord. I don't have the strength to do what's needed in order to fulfill my pastoral call here. This deeply grieves my heart.

And so after much prayer and wrestling, I offer you my resignation as pastor of the Elkhart RPC. I do so with tears and deep concern for you men and the congregation. I pray that the Lord Jesus will graciously and powerfully preserve His church here through this transition. As David pleads, "Oh, save your people and bless your heritage!
