# 2025 Great Lakes/ Gulf Presbytery Meeting Reformed Presbyterian Church of Lafayette

As we look back on 2024, the session has noted on many occasions that we have experienced a great blessing of a season of peace and stability. This is truly a blessing from the Lord of Peace and one we as a congregation need to consistently give thanks to God. The session is vastly aware of God's leading, and provision, and we continue to thank God for using our congregation to build His church in this local community.

One of the greatest blessings in 2024 was the election and eventual ordination and installation of three new deacons. Already we have seen and experienced the blessing of a larger deacon board, and the increased blessings our deacons can be to the congregation and community.

As a congregation, we continue to be blessed by the faithful ministry of our pastoral staff. Our Senior and Associate Pastors work well together in bringing pastoral care and faithful teaching to our congregation. Adam has now finished his seventh full year of ministry here in Lafayette. We are glad that the Niess family was able to take a six-week sabbatical this last summer. Jonathan has now finished one and a half years as our Associate Pastor and he continues to be a blessing in numerous ways.

The preached Word continues to be central to our ministry as a congregation. This year Adam has finished his series on the book of Ezekiel and Jonathan continues in the book of Mark. Please continue to pray for our pastors as they prepare each week and that we continue to love and value the preached Word.

In the fall of 2024, we are also thankful that we have approved Jonathan Park to start a pastoral internship with our session. Please continue to pray for the Lord's leading for Jonathan and Ashley as they continue to consider the call of the Lord toward potential full-time ministry.

Our congregation continues to be involved with ministering weekly at the Tippecanoe County Jail. We also continue to minister to undergraduate and graduate students at Purdue as well as young adults through our CORPS ministry. We also continue to minister to the youth of our church through Youth Group and Sabbath School programs.

In 2024 the session met as a constituted court a total of 24 times. As of 12/31/24, our current membership is 152 (110 communicant members, 42 baptized members.) Net change in total membership is +1 from 12/31/23. Our average attendance for our worship services was 133 (-1 from 2023) in the morning, and 105 (-1 from 2023) in the evening. During the year we have dealt with two discipline cases. Unfortunately, both of those have resulted in excommunications. We continue to pray for those individuals.

As a session, we also continue to be involved in the larger courts of our denomination. At the synod level, Adam is on the International Conference Advisory Committee; Bob is serving as Vice President of the E&P board and is serving on the board of RPTS including chairing the 100 years at Rutherford Hall campaign (with Marlene). At the presbytery level, Adam is serving as interim moderator of Selma, and chairman of the Candidates and Credentials Committee, and speaker for the Fall Ministry Project; Jonathan is serving on the Sparta Shepherding Committee and speaker for the CYPU Winter Conference; Chris is serving on the membership committee; Aaron served as Clerk of Ad Interim Commission for part of 2024; and Ken is serving on the Finance Committee, Ad Interim Commission, and (along with Christy), as Covfamikoi conference directors.

We thank God for how He is guiding our congregation. We continue to seek God in all we do and are grateful for how He continues to fill our cup with his goodness and mercy.
