
To the Great Lakes – Gulf Presbytery:

The session of Westminster Reformed Presbyterian Church is seeking to utilize the Church Revitalization Grant offered through the Vital Churches Committee in order to make some needed repairs to our building. As you may know, our building is over 100 years old. We are incredibly thankful that the Lord has blessed us with these facilities, but with great age comes much upkeep. We believe that the condition of the exterior of our building has become a hindrance to seeing more visitors and return visitors. We had one person comment on a Facebook post, "It looks like we need to organize some restorative maintenance on your facilities in the near future." We even had a visitor write Pastor Smith an email in which he said, "I had the opportunity to visit WRPC today. Having moved to the area I'm looking for a solid biblical gospel preaching church. First impressions aren't everything, but the upkeep of the building itself is very much lacking. Not necessarily a moral thing, except for perhaps in stewardship."


In order to be good stewards of the gifts which the Lord has given us, we are desirous to make the necessary repairs to the exterior of our building. The problem we are facing, however, is that for us to do so out of our own pocket would put a great financial burden on us. This is why we believe this grant is our best opportunity to help us maintain and beautify our property while also presenting ourselves in a more excellent way to those in our community. Attached are several pictures which show the state of our building and what needs to be repaired. Also attached is a quote from a local business estimating the expenses for these repairs.

Per the requirements of the grant, we are asking for Presbytery approval for this request as well as \$2,000 in support of these efforts. The Vital Churches Grant is a matching grant, matching at a 5:1 ratio that which is provided by a presbytery up to \$10,000. It is our desire to see the work here in the NW suburbs of Chicago to continue and not put up any undue hindrances to seeing others find a home here at Westminster.

Remove And Replace All Loose Caulking

Re-Nail All Loose And Protruding Nails In Areas Where Work Is Being Performed

Apply (1) Full Prime Coat

Apply (1) Full Finish Coat

All Colors To Match Existing- *White*

Areas Where Work Is Being Performed Will Be Completely Covered With Drop Cloths And/Or Visqueen

All Personal Property Will Be Protected From Drips

Sherwin Will Need To Use Waterlines/Electrical Lines On The Property At No Extra Charge

A Storage Area Will Be Needed On The Property

Parking For (2-3) Sherwin Vehicles To Be Made Available

All Trees/Shrubs To Be Cut Back A Minimum Of (2') From Surfaces By Westminster

If Items (I.E. Plants, Decorations, Etc.) From The Surfaces To Be Painted- *Only The Surrounding Areas Will Be Painted*

Areas Will Be Accessed By Means Of Ladders And/Or Mechanical Lift
